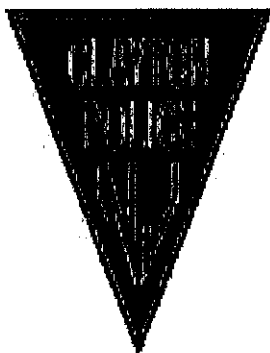

work, and that no one is allowed in her room. Marisa stated M [REDACTED] lied to her about her friends going into her bedroom. Marisa stated she is frustrated with M [REDACTED] behavior and she does not know what to do. I advised Marisa that I would speak to M. [REDACTED]

I then spoke to M [REDACTED]. M. [REDACTED] stated she does not like her mother, and does not get along with her. M. [REDACTED] stated she wants to leave the house. I explained to M. [REDACTED] that she is 14 and needs to follow her mother's rules. I explained to M. [REDACTED] that her mother is a single parent, working multiple jobs trying to provide for her siblings and her. I told M. [REDACTED] her defiance adds more stress for her mother. I told M. [REDACTED] that she needs to be respectful to her mother and follow her mother's rules. M. [REDACTED] did admit that her friends and her went into her mother's bedroom, and she stated she lied to her mother about it. I advised M. [REDACTED] that she needs to be truthful with her mother.

M [REDACTED] stated she wanted to spend the day with her Aunt. I advised M [REDACTED] that I agreed she needed some time away from her mother to calm down and suggested that she ask her mother if she could go see her Aunt. Ptlm. Whitman and I followed M. [REDACTED] inside the residence and had her sit down on the couch with her mother. M [REDACTED] apologized to her mother, and then asked if she could spend the day with her Aunt. Marisa said no, and said her M. [REDACTED] Aunt was at a water park at the shore. Marisa said she was unable to take M. [REDACTED] to her Aunt's location. Marisa then told M [REDACTED] to go to her room and to stay there till she told her to come out. Ptlm. Whitman advised Marisa that an officer would contact DCPD and advise them of the situation. Ptlm. Whitman stated DCPD could provide options for helpful services for M. [REDACTED]. Marisa stated that she understood. I advised Marisa to call the police if M. [REDACTED] began to act out again.

This officer later contacted DCPD and spoke to Kelly # 1559. I advised Kelly of Marisa's concerns and Ptlm. Whitman's and my conversation with Michaela. Kelly stated she would document the incident, and have a case worker reach out to Marisa. Kelly advised me to make Marisa aware of Perform Care, which she stated was a program that could help with M [REDACTED]'s behavior.

M [REDACTED] became verbally disrespectful with her mother using profanity. Ms. Haimes also was using profanity. directed to her daughter. It became a shouting match between mother and daughter. M [REDACTED] stated she was afraid if she went into the house her mother would beat her. M [REDACTED]

M [REDACTED] stated that incident took place last week. She could not remember the exact day. M [REDACTED], her brothers and Ms. Haimes were inside the house when Ms. Haimes became agitated after talking with a family member of the phone. [REDACTED]

M [REDACTED] said she did not want to stay in the house because she was scared of what her mother will do to her.

I transported M [REDACTED] to the police department. I contacted DCP&P and spoke to the after hours emergency case screener. I briefed her of the crises at 280 Novack Drive. I was advised a emergency case worker would call me at the police station. M [REDACTED] said she was hungry. I purchased a pizza for her, which she eat.

M [REDACTED] s Uncle Michael Colaizzo came to the police department. Mr. Colaizzo had originally agreed go over to 280 Novack while Ms. Haimes went to work. Mr. Colaizzo's wife spoke with Ms. Haimes on the phone, upsetting her and this is when Ms. Haimes said she did not want M [REDACTED] at her home. Mr. Colaizzo was willing to take M [REDACTED] if Ms. Haimes was in agreement with it. I received a call from DCP&P emergency caseworker Denise Greene. Ms. Greene said she was in route to 280 Novack Drive shortly. Mr. Colaizzo spoke to Ms. Greene via telephone. Ms. Haimes gave Mr. Colaizzo permission to take M [REDACTED] from the police department. Mr. Colaizzo's residential information was given to Ms. Greene. Mr. Colaizzo left the police department with M [REDACTED]. Ms. Haimes stated she would be available for Ms. Greene when she arrives at her home to conference with her. When Ms. Greene met with Ms. Haimes, Mr. Colaizzo stated he would bring M [REDACTED] home to conference with Ms. Greene.

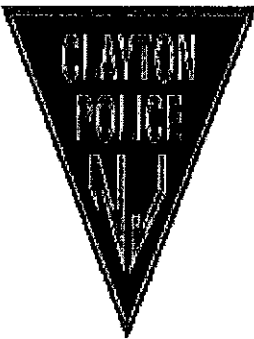
