THIS STATEMENT IS GIVEN OF MY OWN FREE WILL AND IS CONCERNING THE ABOVE NOTED INCIDENT.

I, Baira Chernov, residing at 58 Hancock St, Logan Township, NJ, have repeatedly experienced noise disturbance coming from the occupants of 56 Hancock St. It lasts regularly since September 2021, sometimes acoustic drums, some times loudspeakers. Despite of my attempts to let them know that the noise is disturbing, (on November 10, 2021), they kept disturbing me. The following are only those days when the police witnessed the noise disturbance:

On November 12 - from 2:30 pm to 4:40 pm - playing acoustic drums in a very loud and disturbing manner. I called the police after 2 hours of torture, and the officer came into my house and witnessed the loud noise, she said it was annoying.

On November 17 - from 2:35 pm to 4:25 pm Captain Joseph V. Flatley witnessed them playing musical instrument
