NARRATIVE

On the above date and time this officer received a walk in complaint from a Shanelle West, of 56 Hancock Street. Ms. West wished to speak to an officer about the incident surrounding the investigation of her neighbor, Vladislav Chernov (58 Hancock Street). Ms. West stated that she is concerned that her son is being subjected to harassment and trespassing every time Mr. Chernov steps foot on her property to complain about an alleged noise violation. It should be noted that the above parties have a history of police responses to these residences for Ms. West's son being accused of playing the drums too loud. Each occurrence has resulted in police contacts with no violations witnessed by police. Ms. West advised that as of this date, she has had the police called to her residence yet again while she is coincidentally not home. Ms. West believes that this may not appear as coincidental anymore and stated that she believes Mr. Chernov is trying to intimidate her while trespassing on her property. When asked if Mr. Chernov

has been explicitly advised not to step onto her property, Ms. West stated that Officer Keleshian advised him on November 11, 2021 to stay off the property and stop attempting to make contact with her son. Ms. West also provided video evidence of Mr. Chernov arriving on her door step several times while incessantly ringing her doorbell, after Officer Keleshian's advisement. Ms. West's video of same have been attached to this report for evidentiary purposes. After viewing Ms. West's video, this officer logged into Evidence.com and retrieved Officer Keleshians BWC footage from a prior call for service involving this neighbor complaint (case#: 2021-15410 & 15422). In this video review, Officer Keleshian clearly advises Mr. Chernov to avoid Ms. West's property and specific attempts to harass or engage with her son. Mr. Chernov understood this advisement as explained, however can be seen in Ms. West's ring doorbell footage to be on her property and attempting to make contact several times at her residence. Ms. West was advised that all initial advisements were made to Chernov with no success and that an option to pursue complaints can be completed by this agency. Ms. West wished for the complaint process to be pursued. On 12/21/2021, this officer pursued complaints on SC# 005722 for Defiant Trespassing (2C:18-3B) and SC# 005723 for Harassment (2C:33-4C). Same was hand delivered to Mr. Chernov's spouse with a court date of 1/5/22 @ 0900hrs. All of Ms. West's information was provided to the court administration for subpoena purposes. A video request for Officer Keleshian's BWC was also submitted and a CD copy of same has been attached to this report. This case is closed pending further information.
