NARRATIVE

On 12/19/2021 at approximately 1918 hrs Logan Township Police were advised by County Dispatch that a citizen, Ms. Shanelle West wished to speak with officers about her neighbors and the Logan Township Police harassing her and her adult son. I obtained a phone number for Ms. West and was able to make contact with her moments later.

Ms. West stated that she just had returned from a vacation and upon her arrival at her residence her son advised her that the Logan Township Police came to her residence several times and her neighbor from 58 Hancock Street, Mr. Vladislav Chernov also came to her residence. Ms. West said that this is not the first time this has happened and she is tired of the constant harassment from her neighbor and the Logan Township Police. Ms. West said that since October (2021) her family has been harassed from Mr. Vladislav Chernov and his wife regarding the loud music and the trash cans. Ms. West stated that she has made several modifications to her families lifestyle to satisfy her neighbors, but they constantly contact police about her and her family.

The neighbors from 58 Hancock Street have also contacted Ms. West's landlord and made false reports and allegations about her and her family and they have recently come onto her property and range the doorbell several times.

Ms. West said that she feels that the Logan Township Police are also harassing her family and particularly her son. Ms. West said that police constantly shoot black men and that her son is in fear for his life and afraid everytime he steps outside. Ms. West stated that in societies' climate black men fear for their life and cops shoot black men and put knees on their necks. She stated that the police do not have the right to come to her house asking questions about her son and making her house seem like a problem house in the small community.

I advised Ms. West of the complaint process regarding the harassment with her neighbors and to document everything. She was told to see the municipal court clerk for further information to pursue complaints against her neighbor. Ms. West was also explained that Logan Township Police answer calls of service and respond out to the complaints and investigate what the dispatchers advise them. She was told that her home and her son is not singled out and that the neighbor at 58 Hancock Street was advised if he misused #911 Dispatch against he was have charges filed against him. I told Ms. West that the Logan Township Police were here to serve the community and that we train at higher standards than the rest of the country, so she should feel at ease knowing we watch over her.

Any further displeasure Ms. West wished to pursue with the Logan Township Police Department she was instructed to reach out to the Administration for further direction.

There is nothing further at this time by the Logan Township Police patrols.
