04 May 2019 (Saturday) at 1239 hours

On the above date and time, I was dispatched to 117 Waynewood Park (Forless Towing) on report of an individual who had been bitten by a dog.

Upon arrival, I spoke with one of the employees of Forless Towing, who relayed the victim was driven to  
by another co-worker. I then responded to  
in an attempt to make contact with the victim.

Upon arrival, I spoke with the victim, Evan Leigh, who stated he contacted Forless Towing to have his vehicle towed from US Highway Route-24. Mr. Leigh relayed upon his arrival at the tow company, he exited the vehicle and observed two dogs emerge from the woods on the east side of the property, one of which appeared to be a gray pit bull with white spots. He was unable to provide a description of the other dog. Ms. Leigh stated he reached out his hand towards of the dogs and it attacked him, biting him on the stomach Mr. Leigh then observed two black male juveniles wearing dark clothing chase the dog away and thwart it's attack. Both dogs then ran south bound into the wooded area in the rear of the tow company.

Mr. Leigh stated neither dog was wearing a collar and did not have any signs of ownership. I spoke with the manager of Forless towing, LTD Hannah, who relayed he has previously observed the white pit bull, but does not own the dog.

Plainfield Police Officer R. Lewis and I then responded back to Forless Towing some time later to standby while Mr. Leigh retrieved his vehicle. Shortly there after, Officer Lewis  
Mr. Leigh's and Mr. Leigh left the scene.

On the above date and time, Officer Crawford and I responded to For Less Towing (117 Waynewood Park) a report of a stolen vehicle. Upon my arrival, I spoke to Mr. Nicholas Dicanto, an employee of For Less, who stated an individual stole a vehicle from the parking lot of the business.

Mr. Dicanto relayed to me that at approximately 1245 hours, an unknown hispanic male, later identified as Mr. Walter Barragan, was transported into the parking lot owned by For Less Towing by taxi. Mr. Dicanto articulated that upon exiting the taxi, Barragan then entered a grey colored Nissan Rogue, bearing New Jersey registration C65LEL, and drove off with it. Mr. Dicanto stated he believed the individual was the owner of the car, as he received a telephone call prior to Mr. Barragan's arrival from an individual inquiring on where the business was located and how to pick up the Nissan. Mr. Dicanto stated the vehicle was towed in relation to it's unauthorized presence in a privately owned parking lot in North Plainfield. Mr. Dicanto further stated the towing and storage fees, which totaled to \$305.00 dollars, had not been paid upon Mr. Barrage's taking of the vehicle.

Officer Crawford performed a license plate check of the Nissan's registration through his vehicle's onboard InfoCop system, and said check revealed the owner of the Nissan as Mr. Barragan, who resides at 826 2nd Place, apartment #1, in Plainfield. Officer Crawford, Officer Martinez, and I responded to 826 2nd Place and made contact with Mr. Barragan, who admitted to taking the vehicle.

Civil complaint procedures were explained to Mr. Dicanto.
