Narrative

On this date, Ptl. Brennessel and I responded to 14 Pine Street for a female requesting to speak to an Officer about getting a restraining order against her husband.

Upon arrival, we spoke to the caller/victim, Erica Avery, who stated her husband, Kelly Avery, was coming to the residence to retrieve some of his property and threatened to physically assault her. Erica stated Kelly started doing crack cocaine and she believes he stayed out all night abusing drugs with his employees and friends. Erica said she is afraid when Kelly gets to the residence he will be under the influence of narcotics and physically assault her. Erica said Kelly has been physically abusive to her in the past, but she has never called the Police to report any of the abuse.

Dispatch attempted to make contact with Kelly, but both phone calls got sent to voicemail by Kelly. Ptl. Brennessel made contact with Kelly using Erica's phone and he advised he would be at the residence in a half hour. While waiting for Kelly, I explained Erica her rights as a victim of domestic violence and her right to apply for a temporary restraining order. Erica declined applying for a temporary restraining order, stating she is leaving for Florida at 12:00 hours today with her two sons to stay with family. Erica said the flights are already booked and Kelly knows she is leaving with their sons, but she told him she is going to California to visit her family.

Erica signed off and was given a copy of a VINE form. Kelly retrieved his belongings and was told he could come back to the residence after 13:00 hours, as Erica would be gone by then.
