To Whom It May Concern,

Hello my name is Danielle M. Jenkins. I am a 22-year-old, lifelong New Jersey resident, who has lived in Carteret, NJ for their entire lives. It pains me to be writing to you tonight as a voter that has been harassed & intimidated as they try to exercise their constitutional right. I reported to my local polling station, Columbus School, at roughly 5:30PM to cast my vote in our general election. I was thrilled to first register to vote and have tried to vote in every election. I can, since becoming registered to vote. It started off as an initially smooth process but it quickly became one of the most nerve-wracking experiences of my life.

As I was guided into my election booth to cast my ballot, a poll worker by the name of Rob, opened the curtain to let me in. As I am actively making my ballot selection, Rob comes in barges into the booth that I am actively voting in. I was shocked by this and asked him what seemed to be the problem. Rob then takes it upon

himself to ask me "who are you voting for?" and, "Do you even know who Goofer writing in?" I then respond that ~~it~~ it really doesn't matter who I am writing in or voting for and that he can leave as I can read and operate the booth just fine. I waited until Rob, who at that point was disgruntled, to leave the booth so that I could finish casting my vote. I casted my vote and walked out of the booth in a daze, stunned and perplexed at what just happened to me in my hometown. With the many poll workers that were there no one had said a thing to me as I inched out of the location confused and hurt by what had just occurred. I did not even receive an "I Voted" sticker after I cast my ballot.

I went back home to gather myself and decided ~~to go~~ that I needed to go back to the school to ~~at~~ at least mention to his fellow pollworkers what happened to me and to let them know how inappropriate the entire situation was. As I began to give his physical description, an elderly

white man in a black hoodie with no hair silence fell amongst most of the other poll workers. Two other poll workers on the side were whispering amongst themselves and then proceeded to inform me that they knew who I was talking about and that his name was Rob. I repeatedly asked for his last name but it was never given to me. His son, who introduced himself as Robert, apologized for his father and fellow poll workers' actions.

This incident disturbs me on several different levels. As a queer, young, Black non-binary femme, I was deeply disturbed to have an approved and registered poll worker not just watch me as I vote but then proceed to get into the booth with me and quiz me about who and why I am voting. I cannot help but think that this was an event of racial and gender profiling, one that fits into a long and tedious history of women and Black people fighting for their right to vote safely and securely.

In short, this event was completely

and utterly inappropriate and disrespectful. Rob has no business being a poll worker if he believes he can quiz people on their selections while they are simply exercising their constitutional rights. I, as an American, deserve to vote in a safe and secure environment, free from harassment and intimidation of any sort. I am upset, disappointed, embarrassed, and hurt by what has happened to me today. This is wholly disrespectful.

I am calling for Rob to not be allowed to be a poll worker anywhere at anytime. If he can harass me, (a 5'0" woman presenting person whom he does not know at all, he can and will harass anyone. I also implore you all to check if he has had any issues with intimidating voters in the past. Something must be done, and while I will not stop until this issue is fully handled, I hope you will also see how important and serious this incident is.
