The following remarks were made by the Councilmen before they voted:

COUNCILMAN SITAR said he didn't know how the resolution got on the agenda, since the Chief of Police did not recommend the promotions but did recommend the hiring of four (4) patrolmen.

COUNCILMAN SITARZ said that he brought this matter up several months ago and it was being put off. He said there were two openings for Lieutenant and Sergeant and that Makwinski was last on the Lieutenants list before the test expires and he deserves to be appointed. "If the Chief did not recommend this, then I wonder why", he said. COUNCILMAN SITARZ stated that Makwinski could be assigned to the Special Squad #62; that the Chief did recommend the hiring of 4 more patrolmen and in this way we will have a senior officer covering that shift instead of paying overtime.

COUNCILMAN TOTH stated that he feels like Councilman Sitar, that the Chief did not recommend this. He also said that we would have more chiefs than indians and was in favor of hiring more patrolmen.

WHEREAS, it is the desire of members of the Council of the Borough of Carteret to make appointments to the office of Police Lieutenant and Police Sergeant;

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED that CHARLES MAKWINSKI, JR. be promoted to the position of Police Lieutenant, and JOSEPH BARANY be promoted to the position of Police Sergeant to serve as provisional appointees pending Certification by Civil Service, effective December 19, 1979.

Ordinance #79-19 was introduced and passed upon first reading at a Regular Meeting of the Borough Council held on December 4, 1979. It was duly published in The News Tribune on December 7, 1979 with notice that it will be considered for final passage after public hearing to be held on December 18, 1979, at 8:00 P.M. The Ordinance was posted on the Bulletin Board and copies were made available to the general public and according to law, the Clerk read the ordinance by title.

Councilmen Sitar and Toth, with a unanimous affirmative vote of the full membership present, moved to open the public hearing. Before opening the hearing to the public, the Mayor stated that he made these recommendations to the Council. The ordinance was composed of a 7% raise plus some adjustments that he thought were necessary. He explained that he took into account the position, years of service, forthcoming retirements and compared them with neighboring communities. He noted that the Mayor has been making salary adjustments for the past several years and he was making a final adjustment this year. He said that this would be the last adjustment for the supervisors and hereafter everyone would receive the same raise.

He then declared the public hearing to be open:

LOUIS MANGIERI said that he did not agree with the percentage raises and pointed out that other employees will be negotiating soon and will be asking for the same thing. He said this was a big jump for the supervisors, and he couldn't see them going up that high. He advised the Mayor to forget about the other towns; stated that the Mayor's Aides' raise was 33% and he was not questioning this because she was his daughter. He also asked where the money was coming from. The MAYOR replied that the Aide would only be getting \$4.62 and he did not recommend this because she was his daughter, but, because it was the lowest part-time salary. He said that the money was set aside for the raises. MR. MANGIERI said that there were other people lower than that. The MAYOR said that these adjustments would put the people on the same level as surrounding communities and hereafter they would receive the same percentage.

SAM SEMENZA said that since the Mayor was trying to make everyone equal to outside communities, he should also check with the outside communities, compare the Volunteer Firemen's salary and bring them up to the same level. The MAYOR replied that he intended to look into this.

STEPHEN KRISSAK said that the Mayor favored some people over others; that a percentage raise was not fair because the highest paid gets the highest raise and the smaller guy works just as hard. The MAYOR replied that once adjustments are made, he was considering putting everyone on steps.

There being no further comments or objections to the Ordinance, the Mayor declared the public hearing to be closed upon MMS&C, by Councilmen Toth and Sitar, and unanimous affirmative vote of the full membership present.

Upon MMS&C, by Councilmen Sitar and Toth, Ordinance #79-19 was finally adopted and upon individual roll call vote, Councilmen Sitar, Toth, and Wutkowski voted in the affirmative for adoption; Councilmen Sitarz, Umansky and Wilson voted "NO". The vote constituted a tie and the Mayor was called to cast his vote. He said that these were his recommendations and his vote was "YES". The Ordinance was adopted.

The Councilmen made the following remarks before they voted:

COUNCILMAN SITARZ said that some of the figures are 'astronomical', yet, the watchman was only getting a nine cent raise; Supt. of Recreation, Ass't Supt. of Recreation and Recreation Supervisors a \$500.00 raise and the School Traffic Guard eleven cents. He noted that in 1972 when GATX went on strike, the employees settled for a dime over the percentage called for by Washington; management took it before the pay board and the employees lost the ten cents because they had to keep in line with the President's guideline. He said some of the people were deserting of the raise, but some were not.

COUNCILMAN UMANSKY said that he disagreed to the manner in which these raises were presented to the Council. Normally, he said, the Mayor and Council sit down together to discuss and make recommendations, but, apparently, the Mayor, by himself, or with the Tax Collector....I don't know what to say....but, anyway, since it was presented...Council never discussed the ordinance. He went on to say that he tried to discuss this at the Agenda Meeting, but, unfortunately, the Mayor had a personal problem and since there were only four (4) Councilmen present, it was unfair. He said that he casually told the Mayor that he was not in favor of the raise for the Mayor's Aide; that she was a part-time worker and will be making as much as a Councilman. The MAYOR pointed out that other part-time workers are also making as much and some, for instance, the Recreation Supervisors, are making more.

COUNCILMAN UMANSKY said that he agrees with the raise for the Chief of Police because if the Captain is making \$23,000.00, he, as a Superior, should be making more and would be getting a comparable salary to other towns. He stated that when the Fire Department and other departments come in with charts of other towns, the Mayor always was the one who said he was not interested in the surrounding areas, that he is interested in Carteret. COUNCILMAN UMANSKY said he was looking for a fair and equitable salary for everyone, but many of them were way out of line....one was the Assistant Tax Collector, who started as a Bookkeeping Machine Operator in 1977, then became a Principal Clerk Bookkeeper and now is the Assistant Tax Collector and instead of starting at that job at the first year rate, she is getting the 3rd year rate and a \$3,000.00 raise. He said it was unbelievable. He pointed out that the Welfare Director was only getting a straight 7% raise and was the lowest paid supervisor. The Magistrate, he said, has been getting a \$1,000.00 raise for the last three (3) years, but, at least, he is bringing in \$45,000 to \$55,000 a year to the Borough. He said he firmly disagrees with the Ordinance.

COUNCILMAN WILSON said he spoke to the Mayor and hopes the future Council will consider in making Mr. Stark a Supervisor with an appropriate salary. He stated that Mr. Stark was not appreciated last year and is doing a good job. He stated that the Recreation Department is getting a fairly good raise, so, must have been doing a good job. The Municipal Clerk puts in many hours and is present whenever the Council meets, so there are many justified raises, but, some of the raises could have been used to appoint a Lieutenant and Sergeant to the Police Department.

The MAYOR advised that Mr. Stark got what he asked for in a raise and that some of the people who are on an hourly rate, will be made salaried and their salaries will be properly adjusted, next year, and that Mr. Stark will be one of them.

COUNCILMAN TOTH made a motion that all bills appearing on the prepared list, properly audited and signed, be paid. Motion seconded by Councilman Wutkowski. Upon individual roll call vote, Councilmen Sitarz voted "YES" for the payment of all the Sewage and Buildings and Grounds bills, which he reviewed and signed, and "NO" on all other bills; Councilman Sitarz voted "YES" on all bills, but, "NO" on his bill as a Volunteer Fireman; Councilmen Toth, Umansky and Wilson voted "YES" on all bills and Councilman Wutkowski voted "YES" only on the Buildings and Grounds bills and "ABSTAINED" on all other bills, including his own as a Volunteer Fireman.

The Mayor announced that the Re-organization meeting of the Mayor and Council will be held on Tuesday, January 1st, 1980, at 12:00 Noon in the Council Chambers.

PUBLIC SAFETY: Councilman Sitarz reported that there was a bad spill in the Borough caused by a truck carrying cresol from a local industry. He said the spill occurred when the cap on the tank of the truck came loose and as the truck

stopped, the chemical 'sloshed' onto the road. He said that no one knew how serious this was until Tuesday morning. He said that on that morning, he was driving on Roosevelt Avenue and saw the Street Department sanding the road. Officer Rivers told him of the spill and when he smelt the stuff, he sent them to GATX to find out what the substance was. He said the chemical was cresol, could cause burn, and kill if breathed at close quarters, but no one knew what it was and that it was dangerous. He reported that he has arranged for a course to be taken by the Police Department which will teach them how to read shipping manifests that give the name of the chemical, and its toxic evaluation, so they would be aware of the chemical that is being carried.

The MAYOR pointed out that we have an emergency number that you are supposed to call in an emergency; that the road should have been barricaded, the number called and within 15 minutes we would have known what the substance was. He stated that each police car should carry the chemtrack number.

COUNCILMAN SITARZ said the course will be given to the Police Department because they are the first ones on the scene. He said that maybe the incident will help push the Industrial Road.

He reported that the new Police Facility was inspected by the State and got a commendable rating and that someone ran their car on the Fire House lawn, causing damage; that the Police took pictures and that the estimate of the damage will be turned over to his insurance company. COUNCILMAN SITARZ stated that his trucks are in A-1 condition and commended Mr. Zullo for the good work. He also reported that the problems on the new Police Facility have still not been resolved.

PUBLIC WORKS: Councilman Umansky stated that he still was not satisfied with the condition on Roosevelt Avenue; that he did receive a reply from Mr. Carr as to what is going on but nothing is being done. He said that he also received a copy of a letter from Mr. Kady that he wrote to the contractor asking for the video reports so Mr. Carr could determine if more work is needed; that he spoke to Mr. Kady last night and told him how concerned he was with the hazardous condition of the road and Mr. Kady said he was not aware of this, but, would look into the matter. COUNCILMAN UMANSKY noted that Roosevelt Avenue was a county road and he wondered if the County was aware of this condition...perhaps, if they did, they would be able to expedite the problem sooner.

He also reported that he asked Mr. Stark to make a Menorah to add to the Christmas display around the Borough Hall, which he did and he would like to compliment him on a job well done.

BUILDINGS AND GROUNDS: Councilman Wutkowski stated that there were a lot of decorations around the Borough Hall this year and there were quite a few people responsible for them. Mr. & Mrs. Joseph Geczi from Longfellow Street donated the tree and Mr. Stark and his Department cut down and decorated the tree. Mr. Stark was also responsible for getting the artificial trees from the Shopping Center and he, together with his Department and John Bohacs and his crew, helped put them up. He asked the Clerk to send a letter of thanks to Mr. & Mrs. Geczi, Mr. Stark, Parks Department, Mr. Bohacs and his Assistant. He then wished everyone a Merry Christmas.

SEWAGE DISPOSAL: Councilman Sitar also thanked Mr. Stark and everyone for the decorations and wished everyone a Merry Christmas.

All other Standing Committee Chairmen reported Progress in their respective departments.

The Mayor, too, extended greetings for a Happy Holiday to all and opened the meeting for public discussion. No one in the audience wished to be heard and the public discussion was closed.

There being no further business from the Council or public present, the meeting was adjourned upon MMS&C, by Councilmen Toth and Umansky to the call of the Chair.
