Ordinance of the Borough of Carteret, N. J.

ORDINANCE PROVIDING FOR WHITTIER STREET AND
WHEELER AVENUE SEWER PROJECT OF THE BOROUGH
OF CARTERET, IN THE COUNTY OF MIDDLESEX, NEW
JERSEY, APPROPRIATING THE AGGREGATE AMOUNT OF
\$40,000 THEREFOR FROM THE CAPITAL IMPROVEMENT
FUND OF THE BOROUGH FOR THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF CARTERET, IN THE
COUNTY OF MIDDLESEX, NEW JERSEY AS FOLLOWS:

Section 1. The improvement described in Section 2 of this BOND ORDINANCE is hereby authorized to be undertaken by the Borough of Carteret, New Jersey as a general improvement. For the improvement or purpose described in Section 2, there is hereby appropriated the sum of \$40,000 for the improvement or purpose described therein which amount is made available from the Capital Improvement Fund of the Borough.

Section 2. The improvement hereby authorized and the purpose for which the appropriation of Capital Improvement Fund money is made available is to provide for the reconstruction and repair of sewer lines along Whittier and Wheeler Avenue in the Borough, including engineering expenses and also including the acquisition of all work and materials necessary therefor or incidental thereto.

Section 3. The Capital Budget of the Borough of Carteret is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith.

Section 4. The purposes described in Section 2 of this Bond Ordinance are not current expenses. They are all improvements that the Borough may lawfully undertake as general improvements, and no part of the costs thereof has been or shall be specially assessed on property specially benefited thereby.

Section 5. This Ordinance will comply with Ordinance Number 78-23 and Number 84-6, authorizing all appropriate Sewage Expenditures generated by this Ordinance to be applied to Sewage Revenues and Surplus.

Section 6. This Ordinance shall take effect after final adoption, as provided by law.
