Ryan wanted a check welfare done on E■■■■ to make sure that she is okay.

At this time I responded out to 24 Plum Ridge Dr to meet with Alyssa and E■■■■. I was able to speak with E■■■■ who advised me that she is okay, there was no signs of any issues at this time. Ryan wanted this incident documented in case any further actions occur. No further police actions taken at this time.
