RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT WITH
THE CITY OF PATERSON FOR ANIMAL CONTROL SERVICES FOR 2019

WHEREAS, the Mayor and Council of the Borough of Totowa desire to retain the services of a qualified company to serve as Animal Control Officer for the Borough of Totowa by providing a variety of animal control services for the residents of the Borough of Totowa and for the public good; and

WHEREAS, the Mayor and Council of the Borough of Totowa did on two occasions advertise for receipt of sealed proposals for the professional animal control services in accordance with its specifications entitled "Request for Proposals for the Position of Animal Control Officer for the Borough of Totowa"; and

WHEREAS, the Borough of Totowa did not receive any proposals at its Municipal Building on December 20, 2018 or March 7, 2019; and

WHEREAS, the Mayor and Council of the Borough of Totowa have determined that it would be more cost effective to subcontract for animal control services through the implementation of a Shared Services Agreement with the City of Paterson; and

WHEREAS, the Mayor and Council have further determined that it would be in the best interest of the residents of the Borough of Totowa to enter into a Shared Services Agreement for animal control services because these services can be more efficiently and economically provided to the Borough of Totowa through said agreement; and

WHEREAS, the New Jersey Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., authorizes the City of Paterson to provide animal control services to the Borough of Totowa; and

WHEREAS, the parties are desirous of entering into a Shared Services Agreement which would authorize the City of Paterson to provide animal control services to the Borough of Totowa; and

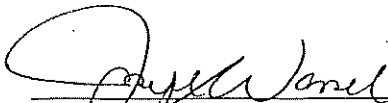
WHEREAS, the Borough of Totowa shall pay the City of Paterson a monthly fee of \$1,000.00 for animal control services for the period of April 1, 2019 through December 31, 2019, plus overtime pay in cases of emergency, for a pro-rated annual fee not to exceed \$9,000.00.

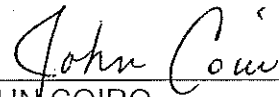
NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Totowa do hereby authorize the Borough of Totowa to enter into a Shared Services Agreement with the City of Paterson to provide animal control services to the Borough of Totowa effective April 1, 2019 through December 31, 2019.

BE IT FURTHER RESOLVED, that the Municipal Council of the Borough of Totowa does hereby authorize the Mayor and Municipal Clerk to execute any and all necessary instruments relating thereto.

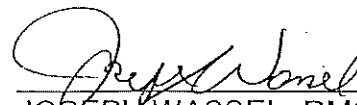

COUNCILPERSON Introducing the Following Resolution:

WHEREAS, N.J.S.A. 40A:65-1 et seq., known as the "Uniform Shared Services and Consolidation Act," was enacted to facilitate and improve the use of shared and consolidated services among municipalities and other local government entities, so that services may be provided efficiently and effectively; and

WHEREAS, the Boroughs of Haledon and North Haledon wish to enter into a shared services agreement to secure services from the City of Paterson, Division of Animal Control; and

WHEREAS, the City of Paterson agrees to provide its existing animal control services presently provided to residents of the City of Paterson to the residents of the Boroughs of Haledon and North Haledon, with the exception that the City of Paterson will not patrol for stray dogs or cats and will not pick up stray dogs or cats on calls from residents or borough officials unless the caller can identify the specific location of the dog or cat, nor will the City pick up any forms of wildlife, including but not limited to raccoons, opossums, skunks, gophers, beavers and/or groundhogs with the exception that same will be picked up only if sick or injured, otherwise, wildlife may be transported in a trap to the Animal Control Division of the City of Paterson or picked up by an outside agency at no expense to the City of Paterson; and

WHEREAS, the Boroughs of Haledon and North Haledon agree to pay to the City of Paterson the sum of \$600.00 per month in return for said services and \$400.00 per month for "on-call" services for a total amount of \$1,000.00 per month with payment to be made on the first day of each month to the attention of the Police Director; and

WHEREAS, in the event any City of Paterson employee shall be entitled to overtime pay as a result of providing services outside the normal working hours to the Boroughs of Haledon and North Haledon, or any resident thereof under this agreement, each borough agrees to reimburse the City of Paterson for all payment it makes as a result of such employee overtime.

WHEREAS, these Agreements shall remain in effect for a period of three (3) years from April 12, 2016 through April 11, 2019 with the parties retaining a mutual option to extend this agreement for two (2) additional years under the same terms and conditions.

WHEREAS, the Boroughs of Haledon and North Haledon will each authorize entry into the shared services agreement with the City of Paterson by resolution of their respective Governing Bodies.

NOW THEREFORE BE IT RESOLVED by the Municipal Council of the City of Paterson that the Municipal Council authorizes the City of Paterson, to enter into shared services agreements, the terms of which are consistent with the obligations set forth in this Resolution, with the Boroughs of Haledon and North Haledon for a three (3) year period with a mutual option to extend the agreement for an additional two (2) year period under the same terms and conditions.
