Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On September 26, 2017, a search warrant was executed at the address of 32 Eucalyptus Court Jackson, New Jersey. OCPO Officers, Jackson PD Officers and a HSI Agent conducted a knock and announce search warrant. Officers identified themselves as Police and notified they were there for a search warrant. After OCPO and Jackson PD made multiple knock and announce attempts identifying police presences and their reason being a search warrant, Marano did not open the door. Movement was visible inside the residence. The door was breached, Marano was in the hallway outside of his bedroom with the loaded handgun in his right hand. Anthony J. Marano displayed a loaded handgun during the execution of a search warrant at his residence, it was visible to multiple officers at time of entry.

During a search of the residence, a HP laptop computer was located in Anthony Marano's bedroom as well multiple CD-R's. Following an on scene preview files indicative of child pornography were located on both of the HP laptop and CD-R's. Located at the residence was Anthony Marano who was the sole resident. Multiple images located on the HP laptop were images of child pornography included in a 2016 NCMEC Skype investigation connected to [REDACTED] Jackson, New Jersey.
