Dear Sir/Madam:

Please be advised that your request for “any and all records” is impermissibly vague and overbroad, as it does not identify any specific records or documents in existence. Additionally, compliance with the request would require research, analysis and judgment by this office, which is prohibited by OPRA:

While OPRA provides an alternative means of access to government documents not otherwise exempted from its reach, it is not intended as a research tool litigants may use to force government officials to identify and siphon useful information. Rather, OPRA simply operates to make identifiable government records “readily accessible for inspection, copying, or examination.” See MAG Entm't, LLC v. Div. of Alcoholic Beverage Control, 375 N.J. Super. 534, 546 (App. Div. 2005)

Based on the foregoing, you must identify specific documents or we will be unable to satisfy your request for records. However, please be advised that some documents, such as police/investigation reports, are criminal investigatory records, and as such, they are exempt from disclosure under OPRA, pursuant to N.J.S.A. 47:1A-1.1, et seq. Should you disagree with our decision, please contact us in writing with your concerns so that we may consider them.
