Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

I, Task Force Officer Vincent Roselli, of the Monmouth County Prosecutor's Office ("MCPO") Narcotics Strike Force, am the lead officer of the investigation of Anthony Vamvas (and hereinafter, "Vamvas"). I am personally familiar with the facts and circumstances of the investigation. TFO Erick Pardo of the MCPO made five (5) undercover purchases ("UCO") of cocaine from co-defendant A.Q. on the following dates in Long Branch, New Jersey: November 8, 2019, December 4, 2019, January 8, 2020, January 13, 2020, and February 20, 2020. Four items from these UCO purchases were submitted to the New Jersey State Police's Office of Forensic Sciences and tested positive for cocaine. Personnel observed defendant meet with A.Q. during two of these undercover purchases: January 13, 2020 and February 20, 2020. On Friday, February 28, 2020, Judge Marc Lemieux of the Monmouth County Superior Court issued a search warrant for defendant's residence located at 3633 Route 33, Building 15, Apartment 312, in Neptune Township, New Jersey as well as co-defendant A.Q.'s residence located at 255 Sixth Avenue in Long Branch, New Jersey. On March 4, 2020, members of the Monmouth County Prosecutor's Office, Neptune Township Police Department, and Long Branch Police Department executed both warrants. Prior to the execution, TFO Erik Pardo ordered a quantity of cocaine from co-defendant A.Q. . Det. Guy of the MCPO observed co-defendant A.Q. go to defendant's residence and exit. A MV stop was conducted of A.Q. and he was found in a possession of cocaine. Personnel executed the search warrant at the defendant's residence. Located was several bags of heroin, a quantity of cocaine in excess of five ounces, a digital scale, and U.S. currency. The suspected cocaine and heroin were consistent in appearance, packaging, and color to CDS. As a result, defendant was arrested due to the described facts.

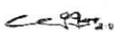
