On 7-26-2017 I responded to a report on a report of an unresponsive person. Upon arrival, I met with a Mr. J. he related to me that his friend was in his room sleeping and she was not responsive. He then took me to the bedroom and I observed a light color skin female laying face down on the bed. I immediately went to check her pulse, she had no pulse and her body was cold to the touch. I then attempted to move the body but she was stiff and appeared to be in the stage of rigor mortis. This officer then requested an ambulance, ALS, and Unit 122 (Sgt. Lenoy) to respond to the above location. I remain by the bedroom door to secure the scene.

I then spoke with Mr. and he informed me that he only know the unknown female's first name (Rena). He then related to me that she contacted him on his cell phone at approximately 2200hrs yesterday to see if she could come over. The female then arrived by taxi at about 2300 hrs and he paid for her fair. They then went to his apartment and she request for an alcoholic beverage. Since he didn't have any at hand he went to the local liquor store to purchase a six pack of Heineken. Once he return the female then drank about four beer and she smoked what he believe was a joint of marijuana. After that he advised me that they had unprotected sexy and went to sleep at approximately midnight. When he woke up this morning to get ready to go to work, he attempted to wake up the female with negative result. After numerous attempt to wake up the female he then call for medical attention.

PFD 91 and ALS 701 arrived to my location. They then attempted to give the female immediate care. ALS 701 then contacted Dr. Boulos and he gave the pronouncement of the time of death of 0602. At this time Unit 122 arrived on scene and was informed of the incident. Mr. advised me that the female purse was on the table in the bedroom. I then found the purse and checked to see if there were any form of identification with negative results but it did contain two container of medication (Alprizolan and Hydroxyzine) for a Rena Terc. Mr. then related to me that he believes that the female lives at 472 12th Avenue. I then contacted Unit 115 (Officer Toledo) to check if the female lives at that location. Unit 115 advised me that he arrived at 472 12 Avenue and saw that the mailbox contained the female's name (Rena Terc) and a Sylvia Terc for a basement apartment. He then attempted to gain contact with anyone who live at that apartment by knocking on all the windows and door with negative results.

Unit 122 contacted the main desk (Officer Castillo) for him to call the on call detective. Officer Castillo then spoke with Detective B. Ramos and informed of the incident. Detective B. Ramos then spoke with Unit 122 and advised him that he will be reporting shortly at my location. I then contact the Medical Examiner Office and spoke with a Ms. Garner. I provided her all the information regarding this incident. She informed that a Medical Examiner will be responding to my location.

Detective B. Ramos and Detective M. Martinez arrived on scene. I then provided them all the information that I had obtain during my preliminary investigation. They both then began their investigation and spoke with Mr. The Medical Examiner (Christian Torres) arrived on scene. Mr. Torres then had the body of the female removed from the above location at 0842 hrs. I then gave Detective B. Ramos the female's belongs that contain a tan purse with the two medication and a pair of blue jeans. I advised the Mr. Beato that he can now enter his room and that the detective will contact him if they any other follow up questions.

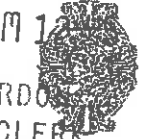

On January 18th, 2018, this writer was assigned to an extra-duty detail at the John F. Kennedy educational complex located at 61-127 Preakness Ave. I was assigned to this detail along with Off. W. Niebanck. Off. W. Niebanck and I were both dressed in full police uniform with our badges clearly displayed on our breast area. At approximately 11:45 AM, Off. W. Niebanck and I were positioned near the main entrance door when the school security staff informed us that a fight had broken out between groups of female students. Off. W. Niebanck and I responded to the area of the fight, at which time we observed a group of female students engaged in a physical altercation. The females involved in the fight were later identified as S O , K M , K M , K M and S B . We were also later advised that K K and K McKinney were sisters. Off. W. Niebanck and I observed the McKinney sisters engaged in a physical altercation against the other two students, S O and S B . The females were striking each other with closed fists and pulling each other's hair.

This writer approached three of the females engaged in the fight (K McKinney, K McKinney and S O) to separate them. I was able to separate the two females apart, at which time K McKinney approached me in an aggressive manor and proceeded to shove me. K McKinney pressed both of her hands against my chest and proceeded to push me while saying "get the fuck off my sista bitch". This writer immediately grabbed K McKinney and advised her she was under arrest. I transported her to the security office to remove her from the large crowd that had not yet dispersed. This writer then attempted to place K McKinney in hand restraints, at which time she refused to allow me to do so. I repeatedly advised K that she was under arrest and to stop resisting, at which time she began flailing her arms wildly in an attempt to prevent me from placing her in hand restraints. K stated "fuck you bitch, suck my dick" while she continued to resist my control. This writer was finally able to restrain her enough to place her under arrest without any further incident.

While this writer was placing K under arrest, Off. W. Niebanck was assisting the faculty members with separating S B and K M , who were engaged in a physical altercation. According to Off. W. Niebanck, S E and K M were striking each other with closed fists when they were separated. Off. W. Niebanck placed S B in handcuffs and transported her to the security office.
