***** PARTIES INVOLVED ***** ROLE: Victim NAME: VALVERDE, EVELYN HEIGHT: 0' 0" ON SUNDAY AUGUST 26, 2018 AT APPROXIMATELY 0147 HRS PO MORILLO AND I RESPONDED TO THE AREA OF 40-1 RIVERWALK PLACE ON A REPORTED DISPUTE. UPON ARRIVAL I MET MR JEAN VILLACRESES. MR VILLACRESES WAS HIGHLY INTOXICATED AND STATED THAT HE WAS ASSAULTED OUTSIDE SON CUBANO, MORE SPECIFICALLY, HE WAS PUNCHED ON THE MOUTH. HE FURTHER STATED THAT HE WAS ACCUSED BY A FEMALE INSIDE SON CUBANO OF TOUCHING HER VAGINA. HE FURTHER STATED THAT ONCE OUTSIDE THE BAR, THE FEMALE'S BOYFRIEND ASSAULTED HIM. MINUTES LATER, PO HENRIQUEZ ARRIVED TO MY LOCATION FROM SON CUBANO AND INFORMED ME THAT HE WAS DISPATCHED TO SON CUBANO FOR THAT DISPUTE PRIOR TO MY ARRIVAL. PO HENRIQUEZ INFORMED ME THAT WHILE SORTING THINGS OUT MR VILLACRESES TOOK OFF AND LEFT THE AREA. PO HENRIQUEZ WAS ABLE TO PROVIDE ME THE NAME OF THE FEMALE. SHE GAVE OFFICER HENRIQUEZ THE NAME OF EVELYN VALVERDE. PO HENRIQUEZ INFORMED ME THAT EVELYN ONLY WANTS THE INCIDENT TO BE DOCUMENTED AND THAT SHE DOES NOT WANT TO FILE ANY CHARGES AGAINST MR. VILLACRESES FOR TOUCHING HER VAGINA. MR VILLACRESES WAS INFORMED THAT HE COULD TAKE IT TO COURT HIMSELF IF HE WISHES TO PRESS ANY CHARGES AGAINST EVELYN. THE MALE PARTY THAT ASSAULTED HIM WAS NOT IDENTIFIED DUE TO HIM BEING GONE PRIOR TO MY ARRIVAL. MR VILLACRESES WAS TRANSPORTED TO PMC. NOTHING FURTHER.
