ORDINANCE NO. 1704

**AN ORDINANCE OF THE BOROUGH OF SEASIDE PARK, OCEAN COUNTY, NEW JERSEY,
AMENDING CHAPTER 435 ENTITLED "VEHICLES AND TRAFFIC"**

BE IT ORDAINED by the Borough Council of the Borough of Seaside Park, County of Ocean and State of New Jersey as follows:

SECTION 1. Section §435-19 of the Code of the Borough of Seaside Park entitled "Schedule IV. Parking Time Limited on Certain Streets" is hereby amended and supplemented to read as follows:

In accordance with the provisions of §435-7, no person shall park a vehicle for longer than the time limit shown, at any time between the hours listed, upon any of the following streets or parts of street:

- A. Central Avenue – center median parking across from any business:
time limit shall be 60 minutes from 8:00 a.m. to 5:00 p.m.
- B. Central Avenue – curbside parking in front of any business:
time limit shall be 30 minutes from 8:00 a.m. to 5:00 p.m.
- C. Boulevard – curbside parking in front of any business:
time limit shall be 30 minutes from 8:00 a.m. to 5:00 p.m.

SECTION 2. All other ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

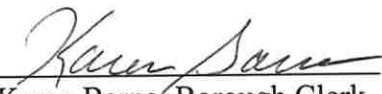
SECTION 3. In the event that any portion of this ordinance is found to be invalid for any reason by any court of competent jurisdiction, such judgment shall be limited in its effect only to that portion of the ordinance actually adjudged to be invalid, and the remaining portions of this ordinance shall be deemed severable therefrom and shall not be affected.

SECTION 4. This ordinance shall take effect upon final passage and publication in accordance with law.

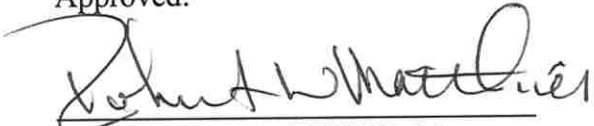
NOTICE OF PENDING ORDINANCE
