Please be advised that I represent the Township of Clark in regard to your OPRA request. Please address all future communications to my attention at **RVarady@lbvklaw.com**. The Township Clerk received your Open Public Records Act (OPRA) request on May 9, 2024. As such, the seven (7) business day deadline to respond to your request is May 20, 2024. This response to your request is being provided to you on the 2nd business day after the custodian's receipt of said request.

Your OPRA request sought access to the following:

“A copy of the video of Mayor Bonaccorso's speech posted to the Clark Township YouTube page on April 5, 2022. Also a copy of the transcript that Mayor Bonaccorso is reading from in the video.”

The following records are being provided in their entirety and are responsive to your request:

- 1. Video of Mayor Bonaccorso's speech**
- 2. Copy of paper Mayor Bonaccorso was reading from during the speech on video.**

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the clerk to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The Council can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
