As such, the seven (7) business day deadline to respond to your request is February 12, 2025. Your request sought access to the following: **The application for and the agreement being considered for long term tax exemption for the property at 27-29 Westfield Ave Clark NJ**

Please be advised that your request is denied as the Township does not maintain records that are responsive to this request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the clerk to

You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The Council can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
