Dear Mayor Berger, Deputy Mayor O'Donnell, Councilwoman Richmond, Councilman Russo and Councilman Bonevich,

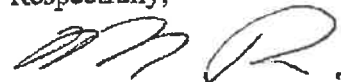
One of the more consequential roles of the elected governing body is the appointment of municipal residents to the Planning and Zoning Boards, whose statutory duties set forth by the Municipal Land Use Law (MLUL) are largely independent of the governing body. Over the last few years, I have become increasingly active in our community by attending various public meetings and doing my best to understand the issues. I believe civic participation is not only a duty, but the cornerstone to democracy. To that end, I currently serve on the Shade Tree Commission and will begin my term as an elected member to the Freehold Regional High School District Board of Education in January 2020.

Professionally, I work for the Social Security Administration and am required to implement federal policies and regulations in the execution of its disability program. In my current capacity, I work with federal law enforcement agents fighting fraud, waste and abuse. My job is independent of politics as it ought to be. I pride myself on following the rules and expect everyone else should too.

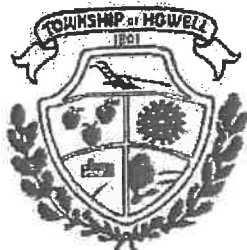
