YOUR LOCAL GOVERNMENT IN LAWRENCE TOWNSHIP

Lawrence Township operates under the Council/Manager form of government and has done so since 1970. Under this form, the major duties of government are allocated as follows:

The Lawrence Township Council consists of 5 residents elected at large by voters of the municipality at the General Election, which is held on the Tuesday after the first Monday in November. The term of office is four years. The position of Council member is considered part-time.

If a vacancy should occur because of resignation or death, it will be filled for the remainder of the unexpired term at the next general election; however, the vacancy will be filled temporarily by Council until the election is held and will be filled by a person of the same political party as the prior member of Council.

The Mayor is elected on January 1st, by a majority vote of all members of Council and serves as such for a period of two years. The Mayor chairs Council meetings and serves as principal spokesperson for the Council during his or her tenure.

Council is responsible for 3 major appointments in the Township; namely, the Municipal Manager, Municipal Clerk and Municipal Judge. Council also appoints residents to many positions on volunteer boards and committees.

Council establishes local government policy and renders decisions on specific matters through ordinances and resolutions.

An ordinance is a governmental regulation which must be introduced on first reading at a regular meeting of Council and then published in the appropriate newspaper of the Township. This must be done at least 7 days prior to the meeting where the ordinance will come up for a vote. When the ordinance is again placed on the agenda, after publication, the Council will hold a public hearing and then vote on the ordinance. The ordinance will then be effective 20 days following the date of adoption, unless it is of an emergent nature.

Ordinances can cover traffic regulations, land use regulations, fees, health regulations, various licensing requirements, appropriating money for capital improvements, etc.

A resolution is an act or regulation which may be adopted at the meeting at which it is introduced and does not require publication. Resolutions cover refunding of monies, releasing bonds, awarding contracts, adoption of the budget, transferring funds, etc.

Most actions of Council require a majority vote of Council to pass (3 affirmative votes); however, budget transfers, emergency appropriations and bond ordinances require a 2/3rds vote (4 affirmative votes).

Council meetings are scheduled for the 1st and 3rd Tuesdays of each month at 6:30 pm. Formal action can be taken at either meeting. The meetings are held in the Council Meeting Room - Upper Level. The public is encouraged to address Council at these meetings during public participation.

The announced schedule of meetings may change because of legal holidays, vacation schedules, etc. Notice of any change is posted on the bulletin board in the Municipal Building and is forwarded to local newspapers.

The Municipal Manager is appointed by the Council and is the Chief Executive Officer of the Township who supervises all departments of the Township government. The duties of the Manager include:

- 1. Executive of all laws and ordinances of the Township.**
- 2. Appoint and remove all department heads, office directors and other officers, subordinates and assistants for whose selection or removal no other method is provided by the Charter. (Employees who do not fall into this category are covered by the New Jersey Department of Personnel/Civil Service).**
- 3. Negotiate contracts subject to the approval of Council.**
- 4. Responsible for preparation of the Municipal Budget.**
- 5. Custody, management and control of all Township property not otherwise assigned by the Code.**
- 6. Attend all meetings of Council with the right to take part in all discussions but without the right to vote.**
- 7. Perform such other duties as may be required by the Charter, ordinance or resolution of Council.**

The Municipal Clerk is appointed for a term of 3 years and if re-appointed attains the status of tenure. The main duties of the Municipal Clerk are:

- 1. Preparation of the agenda and recording of the minutes of Council meetings.**
- 2. Secretary to Mayor and Council.**
- 3. Chief Administrative Officer for all elections.**
- 4. Registrar of Voters for the Township.**
- 5. Administrative Officer in charge of Bingo/Raffle Licenses, Dog/Cat Licenses, Pet Shop/Kennel Licenses, Alcoholic Beverage Licenses, Towing Licenses, Massage Business Licenses, Precious Metal Licenses, Gathering Permits, Solicitors/Peddlers Permits and any other licenses/permits not expressly assigned by the Code.**
- 6. Custodian of the Municipal Seal.**

Residents are urged to call the Office of the Municipal Clerk regarding matters being discussed by Council, items on the agenda, decisions that have been made regarding ordinances/resolutions and for information on any of the above licenses and permits required by the Township. The staff of the Clerk's Office can also be of assistance to residents who do not know exactly who they need to contact with a specific problem.

Municipal courts decide more cases than any other court in the State. The Lawrence Township Municipal Court convenes on Monday evenings at 5:30 P.M. for motor vehicle/traffic cases and one Tuesdays at 8:00 A.M. and Wednesdays at 1:30 P.M. for criminal cases. Often special sessions are scheduled to cover DWI cases or other specific matters.

The Municipal Judge is appointed by Council for a three-year term. The Township provides the services of a Prosecutor and Public Defender for the Municipal Court.

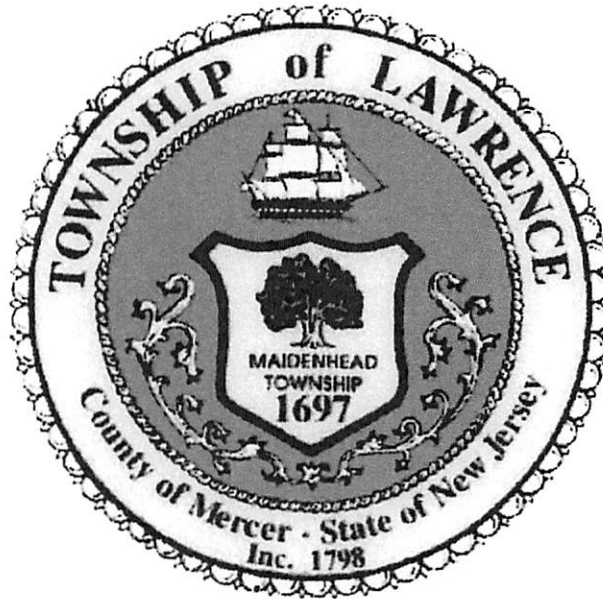
There is a Community Dispute Resolution Committee that is called upon by the Judge to attempt to mediate some of the civil cases that come before the Court that has been very successful over the past years.

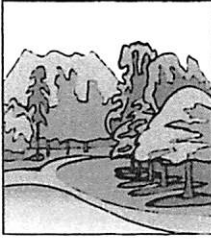
