**RESOLUTION CONCERNING TITLE 39 -
ASHFORD TOWNHOMES**

WHEREAS, the Township of Plainsboro has received a written request from the Ashford at Princeton Meadows Homeowners Association that traffic regulations contained in N.J.S.A. 39:1 - et. seq. be made applicable to private roadways contained in a residential development owned by the Homeowners Association and known as: Ashford at Princeton Meadows; and

WHEREAS, Chapter 5A of Title 39 authorizes such enforcement with the approval of the Commissioner of Transportation; and

WHEREAS, enforcement of Title 39 upon the aforementioned roadways would result in a substantial improvement of traffic control within the Township and benefit the public good.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Plainsboro, County of Middlesex, that it joins with the Ashford at Princeton Meadows Homeowners Association. in requesting that the Commissioner of Transportation undertake all studies and reviews necessary for approval its application for enforcement of N.J.S.A. 39:1 - et. seq. upon its private roadways in the Ashford Townhome Complex.

**R-00-055 RESOLUTION REQUESTING EXTENSION –
DOT MUNICIPAL AID GRANT
NOSTRAND ROAD – SECTIONS 1 AND 2**

WHEREAS, Plainsboro Township has received municipal aid from the New Jersey Department of Transportation for the reconstruction of Sections 1 and 2 of Nostrand Road; and

WHEREAS, due to the reconstruction of the George Davison Road Bridge by Middlesex County in 2000, the Township Committee would prefer to postpone the improvements to Nostrand Road to the 2001 construction season so as to not further inconvenience motorists.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Plainsboro, County of Middlesex, State of New Jersey that for the aforementioned reasons Plainsboro Township is requesting a one year extension on the deadline to award this project.

**R-00-056 RESOLUTION FOR PARTIAL RELEASE OF
PERFORMANCE BOND FOR
CALTON HOMES –ESTATES AT GROVERS MILL, SECTION 3A**

WHEREAS, the Township Engineer has inspected the improvements for Calton Homes – Estates at Grovers Mill, Section 3A, and recommended that the performance bond be reduced to \$7,092.36 and the cash bond be reduced to \$788.04; and

WHEREAS, Calton Homes, Inc., has agreed to post a rider to the Bond No. 3SM91471700 reducing it to \$7,092.36.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Plainsboro hereby accepts this rider and reduces the cash bond to \$788.04, refunding \$1,838.76 to Calton Homes, Inc., for Estates at Grovers Mill, Section 3A.
