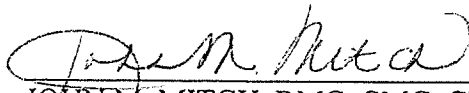

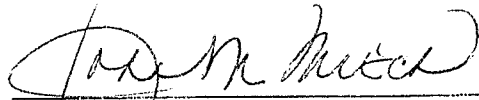
WHEREAS, the Municipal Council of the Township of Woodbridge has had the opportunity to review the qualifications of Kevin Morse;

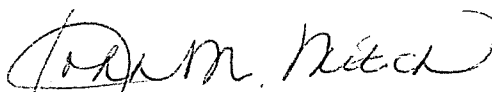
WHEREAS, the Municipal Council of the Township of Woodbridge has had the opportunity to review the qualifications of Joseph A. Lombardi, Esq.;
