7. Any response that is ambiguous or conditional, in any respect, to your giving consent to the taking of breath samples will be treated as a refusal to submit to breath testing.

According to N.J.S.A. 39:3-10.24f, if a court of law finds you guilty of refusing to submit to chemical tests of your breath, then your license to operate any motor vehicle will be revoked by the court for a period of no less than six months and no more than two years. The Court will also fine you a sum of no less than \$250 and no more than \$500 for your refusal conviction.
9. If a court of law finds you guilty of refusing to submit to chemical tests of your breath, and you were operating a commercial motor vehicle, then your commercial driver license will be suspended by the court for a period of no less than one and no more than three years. If your refusal conviction is in connection with operating a commercial motor vehicle transporting hazardous material or displaying a hazardous material placard, then your commercial driver license will be suspended for three years. If your refusal conviction is in connection with a second or subsequent violation of any of the offenses specified at N.J.S.A. 39:3-10.20a, the Court will revoke your commercial driver license for life.
10. Any license suspension or revocation for a refusal conviction will be independent to any license suspension or revocation imposed for any related offense.
11. If you are convicted of refusing to submit to chemical tests of your breath, you must also satisfy the requirements of a program of alcohol education or rehabilitation.
12. I repeat, you are required by law to submit to the taking of samples of your breath for the purpose of making chemical tests to determine your alcohol concentration. Now, will you give the samples of your breath?

line. I then activated my emergency lights and initiated a traffic stop on N. Main St near Herbert Ave. The suspect vehicle was a blue Hyundai bearing NY/HXV9735 occupied by two people.

I called out the plate and made contact with the driver on the drivers side. I asked the driver for his credentials and the female passenger later identified as Alicia McIntyre of Wilmington, Delaware began talking to me asking me what the problem was. The driver identified by his NJ drivers license as Arsemus Nutter Jr. said nothing and handed me his license. I could immediately smell the strong odor of alcoholic beverages coming from inside the vehicle. I visually scanned the inside of the car and saw a cup in the center console of the car. I asked the passenger to hand me the cup and smelled it. It smelled like an alcoholic beverage and when I asked the contents, Alicia said it was her Moscato (wine). When I smelled the drink, I could see two peanuts floating inside it. I placed the drink on the roof of the car and began speaking with the driver.

I asked the driver where they were coming. He did not answer the first time. I again asked him where he was coming from to which he replied "oh, anywhere... I'm just driving". I asked again and he said "driving". I asked him where he was going to which he replied "anywhere, I'm just driving". I then asked him if he had anything to drink to which he replied "no". I asked him his highest level of education to which he replied "uhhh, then gave a long pause and slurred East Brunswick Vo-Tech. I again asked to which he replied the same. Mr. Nutter again said that he had nothing to drink. I asked him if he had a command of the English language to which he replied "who?". I asked him again and this time he stated that he did and said "sure". I asked him to say the English alphabet from "D through R". Mr. Nutter shook his head no. I asked him a final time and this time he shook his head and said "whatever dog". He then repeated several times "I'm fine" and the he was "29 negative". Mr. Nutter was being stubborn and refused to comply with any request I had. As he continued telling me he was "29 negative" I could see in his mouth that he was still chewing peanuts. I asked him to step from the vehicle so I could perform field sobriety testing which he refused maintaining that he was "29 Negative". I told him that he was forcing my hand and that I was going to change this from a simple sobriety test to something more and he said "I don't care" and to "bring everybody". Yelling at me to "bring everybody". I then asked headquarters to contact North Brunswick PD for a backup unit as Ptl. Olesinski was tied up at headquarters with an arrest and Mr. Nutter was rapidly escalating the situation. The passenger Alicia yelled at Arsemus to stop which he refused to do. She was now on the phone with Arsemus' sister Heather Nutter trying to get her to come to the scene. I told Arsemus that the situation did not have to end with him getting arrested but, he was giving me no other options. He continued saying he did not care and he was 29 negative. He then said "I'm not gettin out the car dog". I attempted to explain to Alicia again why I stopped them at which time Arsemus raised his voice and said I was lying. Arsemus continued provoking me to the point Alicia interjected and yelled at him to shut up.

I continued attempting to verbally de-escalating with negative results. At one point Alicia actually put her hand over his mouth to keep him quiet. Alicia pled with me to let them leave to which I replied as soon as I concluded my investigation.

At that time, North Brunswick PD arrived on scene to assist me as backup. I advised him of the situation and then told Mr. Nutter that I just wanted him to step from the vehicle to I could perform my field sobriety testing. I pled with Mr. Nutter telling him that I did not want to arrest him and if he failed to comply with my instructions, I would have no other choice. Alicia again put her hand over his mouth and shouted at him to shut up while he argued with me. I opened the door and told him that I was taking him out of the car. He said "don't touch me". I gave Mr. Nutter ample amount of times to comply with me requests to the point that I stated I was begging him not to turn this situation into me arresting him. As a last ditch effort to appease him, I called his drivers license in to dispatch. He still refused to exit the vehicle. I asked him if he wanted to turn this situation into something it did not need to be and he said "damn right, we gonna roll press". "Spend y'all money". I advised him he was under arrest. He immediately clenched his fists and crossed his arms. I leaned in and placed a handcuff on his left wrist and attempted to remove him from the vehicle. I advised him that I did not want to hurt him. Mr. Nutter straightened his legs and tightened up refusing to exit the vehicle. I attempted to used a wrist lock to remove him but I did not want to hurt him. I could hear Alicia also telling him to please stop. We told Arsemus to stop resisting. I then stepped behind the drivers seat to pull the seatbelt free and ended up cutting it. I struck Arsemus with two knee strikes to the common peroneal nerve in his thigh in an attempt to gain some pain compliance. He started counting how many thousands he was going to receive in his lawsuit. All officers were pleading with him to stop resisting. He kept on saying that he was not resisting but would tense up and not comply. Eventually he was forcibly removed from the car and placed on the ground. He kept laughing saying "I'm getting money". "I love Milltown, I'm getting money, I love it,". The handcuffs were re-applied behind his back and I searched him incidental to arrest. He then repeated numerous times "I needed some money". The handcuffs were double locked and checked for proper fit. I then placed him into the rear prisoner compartment of unit 206 where I

seat belted him in. The rear compartment was checked for any contraband before and after transport back to headquarters where nothing was found.

While at headquarters, I noticed a small laceration on my right wrist and scrape on my elbow but, I did not want to call Qualcare to report it. Mr. Nutter continued his argumentative and provocative behavior. I read his Miranda Warnings card. He would not cooperate with me and would not give me his pedigree information. During processing, he kept telling me that he was going to make me work for my money. He was trying to race bait me and begged me to call him racist names. I contacted Zone Prosecutor and he advised me to charge Arsemus on a complaint summons. I then attempted to get Arsemus to perform field sobriety testing in a controlled environment inside headquarters. Arsemus refused any attempt. I then read him the Standard Statement for operators form which he would not answer affirmatively to. I read the second portion as pertaining to operators refusing to provide breath samples which he also refused to acknowledge. He was later processed and released to his mother Joyce Nutter, fiance Alicia McIntyre and sister Heather Nutter who signed the Potential Liability form. He was released at 00:55.

jobs, the detective bureau was notified to see if there was any open ongoing investigations. After further investigation on the vehicle credentials, it was determined that the temporary license plates as well as registration card was fraudulent. Det Sgt Fama then observed a second temporary license plate in the rear of the vehicle. That plate was a different number but it was printed that it was for that vehicle. A search through DMV database came back without record. I then contacted State Farm from the insurance card provided. A search by the State Farm agent stated that there was not a vehicle with the policy number, nor was there a policy for that vehicle in their system. As I spoke to the passenger, he stated to me that his name was Luke Wall. He stated he was not working, but his friend picked him up from the gym earlier. I then asked the driver, identified through his UK ID card as John Wall, to exit the vehicle. I asked him who the vehicle belonged to and he said his colleague Myles Wall. He stated that it was no relation to him just a co-worker. I then asked him who the passenger was and he stated his brother Luke. a lookup through dispatch came back without results on both parties.

I then began talking to John more and explained to him that I stopped him for a violation of the borough ordinance of solicitation without a permit. He stated he did not actually knock on anyone's door, but did stop and ask people outside their homes to perform work.

Both parties were then transported back to Milltown Police Headquarters in investigative detention for proper identification. While fingerprinting was being conducted, "Luke" did not want to have his fingerprints taken and was questioned about his name again at which time he stated that his name was actually Myles John Wall. He stated that he gave the name Luke so if he got the summons he would not have to come to court. I then asked his brother John why he also lied to me and he did not have a reason why he kept lying about his brother's name. At this time both parties were place under arrest.

Both defendants were processed and charged with soliciting without a permit, hindering and obstruction of justice. John was charged with exhibiting a fraudulent insurance card to officer on a traffic stop as well as ten motor vehicle summons. they were released with a pending court date

8. Any response from you that is ambiguous or conditional, in any respect, to my request that you provide breath samples, will be treated as a refusal to submit to breath testing. Even if you agree to take the test, but then do not follow my instructions, do not properly perform the test, or do not provide sufficient breath samples, I will charge you with refusal to submit to breath testing.

9. I repeat, the law requires you to submit samples of your breath for testing. Will you submit the samples of your breath?

THE ARRESTING OFFICER MUST READ THE FOLLOWING TO THE DEFENDANT:

FULL TEXT OF STANDARD STATEMENT FOLLOWS:

1. You have been arrested for operating a commercial motor vehicle with an alcohol concentration of 0.04% or more.
2. You are required by law to submit to the taking of samples of your breath for the purposes of making chemical tests to determine your alcohol concentration.
3. A record of the taking of the samples, including the date, time and results, will be made. Upon your request, a copy of that record will be made available to you.
4. Any warnings previously given to you concerning your right to remain silent and your right to consult with an attorney do not apply to the taking of breath samples and do not give you the right to refuse to give, or to delay giving, samples of your breath for the purposes of making chemical tests to determine your alcohol concentration. You have no legal right to have an attorney, physician, or anyone else present, for the purpose of taking the breath samples.
5. After you have provided samples of your breath for chemical testing, you have the right to have a person or physician of your own selection, and at your own expense, take independent samples and conduct independent chemical tests of your breath, urine, or blood.
6. If you refuse to give samples of your breath you will be issued a separate summons for this refusal.
7. Any response that is ambiguous or conditional, in any respect, to your giving consent to the taking of breath samples will be treated as a refusal to submit to breath testing.
8. According to N.J.S.A. 39:3-10.24f, if a court of law finds you guilty of refusing to submit to chemical tests of your breath, then your license to operate any motor vehicle will be revoked by the court for a period of no less than six months and no more than two years. The Court will also fine you a sum of no less than \$250 and no more than \$500 for your refusal conviction.
9. If a court of law finds you guilty of refusing to submit to chemical tests of your breath, and you were operating a commercial motor vehicle, then your commercial driver license will be suspended by the court for a period of no less than one and no more than three years. If your refusal conviction is in connection with operating a commercial motor vehicle transporting hazardous material or displaying a hazardous material placard, then your commercial driver license will be suspended for three years. If your refusal conviction is in connection with a second or subsequent violation of any of the offenses specified at N.J.S.A. 39:3-10.20a, the Court will revoke your commercial driver license for life.
10. Any license suspension or revocation for a refusal conviction will be independent to any license suspension or revocation imposed for any related offense.
11. If you are convicted of refusing to submit to chemical tests of your breath, you must also satisfy the requirements of a program of alcohol education or rehabilitation.
12. I repeat, you are required by law to submit to the taking of samples of your breath for the purpose of making chemical tests to determine your alcohol concentration. Now, will you give the samples of your breath?

If the person: remains silent; or states or otherwise indicates that he/she refuses to answer on the grounds that he/she has a right to remain silent, or wishes to consult an attorney, physician, or any other person, or if the response is ambiguous or conditional in any respect whatsoever, then the police officer shall read the following additional statement:

FULL TEXT OF ADDITIONAL STATEMENT FOLLOWS:

I have previously informed you that the warnings given to you concerning your right to remain silent and your right to consult with an attorney, do not apply to the taking of breath samples and do not give you the right to refuse to give, or delay giving, samples of your breath for the purpose of making chemical tests to determine the content of alcohol in your blood. Your prior response, silence, or lack of response, is unacceptable. NARRATIVE

On Friday 09/27/2019 at approximately 00:39, I (Ptl. Olesinski), while being on patrol, observed a silver car turning onto N Main St from John St. As this car turned onto N Main Street and continue to drive northbound, I observed it proceeding at a slow rate of speed and immediately fail to maintain its lane of traffic. I then followed this vehicle on N Main St where I observed it fail to maintain its lane of traffic several more times, proceeding to cross the double yellow line then swerve back into its lane. I would go on to activate my overhead lights and conduct a MV stop onto Milltown Rd just beyond N Main St.

The driver of the vehicle slowly came to a stop in the middle lane of traffic on Milltown Rd, where I approached the car on the driver side. I identified the driver as Jesus...

Claudio-Torres, the registered owner of the car. Jesus was speaking slowly at times and with an accent, appearing to have a slight language barrier between him and myself. Both of Jesus' eyes appeared blood shot and watery, which is consistent with someone under the influence of alcohol or a narcotic. Jesus presented all of his documents, and stated he did not have anything to drink tonight when I inquired. There was a female passenger, Esperanza Avendano-Morales, who was reclined all the way back in the front passenger seat as I spoke with Jesus. Jesus initially stated that Esperanza and he were friends and they were driving from another friend's house in Milltown. Jesus stated his friend lived near Maria's Pizzeria in Milltown, but was unable to provide an address for the house or the friend's name. I radioed for Cpl. Holland to assist me with the MV stop. I notified Cpl. Holland I had suspected Jesus of driving while being impaired and was going to conduct Standard Field Sobriety Tests. As Jesus stepped out of his vehicle, he needed to put his hand onto the car as to catch himself for balance after he stood up.

Standard Field Sobriety Tests**Nystagmus Test:**

I observed Jesus had two working eyes and normal pupil size. I observed equal tracking in both eyes. Jesus had a lack of smooth pursuit in both eyes after several attempts as he continually left his focus from the tip of my pen as I instructed. Jesus had nystagmus at maximum deviation and again would continually lose his focus from the tip of my pen to return his eyes to a more comfortable position. Jesus did not show any onset nystagmus prior to 45 degrees. Throughout the test Jesus was visually swaying and leaning back in an attempt to hold his balance, consistent with someone who is under the influence of alcohol or a narcotic.

Walk And Turn:

I then went on to place Jesus in the starting position for the "Walk And Turn" test informing him to hold that position as I demonstrated and explained the entire test. Jesus would go on to break from the starting position to balance himself numerous times, one time beginning to step and start the test without being instructed to do so. After I had successfully demonstrated and explained the entire test to Jesus, he stated he did not have any questions and began. Jesus went on to miss several heel to toe steps and step off the line approximately 3 times. Jesus also took additional steps beyond the 9 steps he was instructed to take, only stopping to turn around when I finally stopped him. At this time Jesus began to walk backwards taking heel to toe steps in reverse. After I had corrected his positioning to face forward, Jesus went on to miss several heel to toe steps and broke from the line while taking his 9 returning steps. He again took too many steps and only stopped the test when I had told him. The entire test Jesus failed to count his steps out loud as he was instructed.

One Leg Stand:

In the final test, the "One Leg Stand", I put Jesus into the starting position where he held that position as I demonstrated and explained the test. Jesus again stated he did not have any questions and began. Jesus did not count out loud as he was instructed, and placed his foot on the ground for balance numerous times. Throughout the test Jesus was visually swaying in an attempt to hold his balance, while also holding his left thigh with his left hand for balance.

Due to my observations during the MV stop and Jesus' performance on the SFST's, I proceeded to place Jesus under arrest for DWI. Jesus was handcuffed behind his back to proper fit and double locked. A search under incident to arrest yielded no contraband. He was then placed in the rear prisoner compartment of patrol vehicle 204. The rear prisoner compartment remained clear of contraband prior to and post transport, with the beginning and ending mileage being called into dispatch. Cpl. Holland remained on scene with the involved vehicle and passenger. The vehicle was towed by Knoblock's Towing. Cpl. Holland transported the female passenger to the McDonald's further up Milltown Rd where she would be able to safely stand by for a ride. My transport of Jesus to the Milltown Police Department was completed with no issues.

At the Milltown PD I inspected Jesus' mouth for any contraband, yielding nothing, and proceeded to observe him for 20 minutes. During this time Jesus did not belch, cough or regurgitate and was observed continuously. I advised Jesus of his Miranda warning. I then escorted Jesus to the Alcotest 7110 MKIII-C where I collected two valid breath samples. During the Alcotest I used two separate mouthpieces while collecting breath samples and had my radio, cell phone and BWC secured. The Alcotest reading resulted in a BAC of 0.00%. Jesus stated he does not use any medications or narcotics, and refused to submit to a urine sample at this time.

Jesus stated he has no family in the country and lives alone in Edison. He was able to contact a
