Incident Report



On the above date and time, while on foot patrol for Irish Fall Festival near Keenans Irish Pub, located at 113 Olde New Jersey Avenue, I observed a white female later identified as Danielle Oliveira, trying to enter Keenans Irish Pub through the exit. However, Keenans staff was not allowing her to enter. I approached the exit where this was occurring and Keenans staff advised me that she was not allowed to enter and that they wanted Mrs. Oliveira removed from the property.

I then told Mrs. Oliveira that she needed to leave the property. However, she continued to stand at the exit and argue with staff members. I, along with Sgt. Garriott #254, told her that she had to leave and that she was now trespassing. Mrs. Oliveira did not listen to my initial commands and continued to argue with staff members. Keenans staff told Mrs. Oliveira multiple times that she needed to leave the property while in my presence. I had to tell Mrs. Oliveira to leave the property multiple times as well before she reluctantly complied. As Mrs. Oliveira was leaving the property she told me and Sgt. Garriott #254 that she worked for the NJ State Police.

Mrs. Oliveira walked away from Keenans and I, along with Sgt. Garriott further advised her that if she returned to the property she would be arrested. Mrs. Oliveira then left the property.

Approximately 10 minutes later, Mrs. Oliveira returned and attempted to reenter Keenan's property through the exit. I then approached and told Mrs. Oliveira that she was under arrest and placed her in handcuffs. I then escorted her to east side gate of Irish Festival located on 1st Avenue to await transport. While awaiting transport I adjusted and double locked the handcuffs.

Mrs. Oliveira was then transported to the station for further processing by Officer Gonzalez #271.

Supplemental Investigation Report



On Saturday, September 24th 2022 at approximately 2050hrs., I, Lt. Adam McGraw #242 was on foot in the entertainment district, Olde New Jersey Avenue, where the Irish Fall Festival was taking place. I was in the vicinity of Keenan's Irish Pub, 113 Old Olde New Jersey Avenue when I observed Sgt. Garriott and SLEO II Calloway dealing with a unidentified white female at the main entrance to Keenan's Pub. Those two officers then placed the female, later identified as Danielle Oliveira under arrest. I was then approached by a white female, who identified herself as Lt. Cortney Lawrence from the New Jersey Attorney General Office.

Lt. Lawrence asked me what happened with her friend (Oliveira) and I explained that I had just arrived, as the officers were placing her under arrest and wasn't completely sure why she was under arrest. Lt. Lawrence explained that Oliveira is an acting lieutenant assigned to the officers involved shoot team and that she exited Keenan's Bar to take a phone call because there was a police involved shooting in North Jersey. Lt. Lawrence further explained that she also briefly exited the bar because she found a police identification and was trying to call the person on the phone in order to return the identification card. She then said after making the phone call, she returned back in the bar and asked the Keenan's staff if her friend could re-enter the bar. She was advised that Oliveira was not allowed back in the bar. I explained to Lt. Lawrence that Oliveira will be transported to 9th and Atlantic Avenue, North Wildwood Police Department headquarters. She said Oliveira was a sergeant about to make the rank of lieutenant. I advised her that my BWC was activated. I told her that I would speak with Sgt. Garriott and find out what exactly took place and to remain at this location. I deactivated my camera and began walking towards Sgt. Garriott. I then quickly returned to Lt. Lawrence and advised her to meet at 1st and Olde New Jersey Avenue where it was less noise and music. I also advised her to obtain her police identification and driver's license. She said she only had her driver's license and that it was inside the bar. I told her to get her identification and to meet me at at 1st and Olde New Jersey Avenue.

A short time later, I met with Lt. Lawrence at 1st and Olde New Jersey Avenue after I spoke with Sgt. Garriott. Lt. Lawrence presented me with her New Jersey driver's license. I again advised her that my BWC was activated. I again reiterated that Oliveira will be at headquarters and a sober person could sign her out after being given a summons. She then reiterated that Oliveira stepped out of the bar to take a phone call because of a police involved shooting and then learned that the shooting was nonfatal, so she didn't have respond. She then attempted to re-enter the bar but was denied. I told her that I spoke to the sergeant involved with this arrest and that he stated that Oliveira was previously warned by the officers that she was not allowed to re-enter the bar after being escorted out by staff. She tried to re-renter a short time later and was placed under arrest for defiant trespassing.
