Summary

On 8-31-14 at approximately 1330 hours units dispatched to the area of 1608 Kindle Ave for several residents in that area reporting problems with John Munyan. Upon arrival, I spoke with several residents. They advised that Munyan has returned to his former residence, 1608 Kindle Ave, and has been squatting there.
