ON 08/09/23 AT 2209 HOURS:

PTL. NORTH, ALSO OF THIS AGENCY, CONDUCTED A MOTOR VEHICLE STOP NEAR THE INTERSECTION OF ROUTE 9 AND NORTH MAIN STREET. AFTER CONDUCTING THE STOP HE ASKED ME TO RESPOND TO HIS LOCATION FOR ASSISTANCE. UPON MY ARRIVAL I OBSERVED HIM SPEAKING WITH AUGUSTINO AND INDICATING HE WAS GOING TO ASK HIM TO EXIT THE VEHICLE DUE TO HIS ADMISSION OF CONSUMING AN ALCOHOLIC BEVERAGE SO HE COULD DETERMINE IF HE COULD FURTHER OPERATE THE VEHICLE.

AUGUSTINO THEN EXITED THE VEHICLE AND WE ESCORTED HIM TO THE PARKING LOT OF THE LITTLE OWL'S LEARNING CENTER LOCATED AT 542 ROUTE 9, WHICH WAS ADJACENT TO WHERE HIS VEHICLE WAS STOPPED. ONCE IN THE PARKING LOT PTL. NORTH ADVISED HIM I WAS GOING TO CONDUCT THE FIRST STANDARDIZED FIELD SOBRIETY TEST. I ASKED AUGUSTINO IF HE HAD DRANK ANYTHING THAT EVENING AND HE RELATED HE HAD APPROXIMATELY THREE OR FOUR. IT SHOULD BE NOTED HIS EYES WERE OBSERVED TO BE BLOODSHOT AND WATERY AND I DETECTED THE ODOR OF AN ALCOHOLIC BEVERAGE EMANATING FROM HIS BREATH.

TEST 1: HORIZONTAL GAZE NYSTAGMUS (EXPLAINED). SUMMARY OF DIRECTIONS: UTILIZED PEN TIP AS STIMULUS. TOTAL OF SIX FIELDS EVALUATED, THREE FIELDS IN EACH EYE: SMOOTH PURSUIT, MAXIMUM DEVIATION AND ONSET OF NYSTAGMUS PRIOR TO 45 DEGREES. DECISION POINT- FOUR (4). AUGUSTINO WAS ASKED TO STAND WITH HIS FEET TOGETHER AND TO HAVE HIS HANDS REMAIN AT HIS SIDES. HE WAS ALSO ADVISED TO FOLLOW THE TIP OF THE PEN WITH HIS EYES ONLY AND NOT TO MOVE HIS HEAD.

RESULTS: AUGUSTINO DID NOT EXHIBIT RESTING NYSTAGMUS AND HE WAS OBSERVED TO HAVE EQUAL PUPIL SIZE AND EQUAL TRACKING IN EACH EYE. DURING THE REMAINDER OF THE TEST I OBSERVED LACK OF SMOOTH PURSUIT IN BOTH EYES ALONG WITH DISTINCT AND SUSTAINED NYSTAGMUS AT MAXIMUM DEVIATION IN BOTH EYES. I DID NOT OBSERVE ONSET OF NYSTAGMUS PRIOR TO 45 DEGREES. I ALSO DID NOT OBSERVE ANY VERTICAL NYSTAGMUS.

AFTER THE CONCLUSION OF THE TEST, PTL. NORTH CONDUCTED THE WALK AND TURN AND ONE LEG STAND TESTS (SEE...

PTL. NORTH'S INITIAL INVESTIGATION REPORT FOR RESULTS). AT THE CONCLUSION OF THE TESTS AUGUSTINO WAS DETERMINED TO HAVE BEEN OPERATING HIS VEHICLE UNDER THE INFLUENCE OF ALCOHOL AND WAS PLACED UNDER ARREST BY PTL. NORTH. HE WAS HANDCUFFED AND SECURED IN THE REAR COMPARTMENT OF HIS PATROL VEHICLE. PTL. NORTH LATER TRANSPORTED HIM TO HEADQUARTERS FOR PROCESSING WHILE I REMAINED ON LOCATION WITH THE VEHICLE. IT SHOULD BE NOTED AT ONE POINT I DID HAVE TO LEAVE THAT LOCATION TO RESPOND TO AN EMERGENCY MEDICAL CALL BUT SECURED THE VEHICLE AND KEPT THE KEYS IN MY POSSESSION UNTIL I RETURNED. UPON MY ARRIVAL BACK ON LOCATION, SOUTH SHORE TOWING HAD ARRIVED AND THE VEHICLE WAS TURNED OVER TO THEM FOR 12 HOURS AS PER JOHN'S LAW.

UPON MY ARRIVAL AT HEADQUARTERS I ENTERED THE PROCESSING AREA AND OBSERVED AUGUSTINO INSIDE OF PROCESSING CELL #1. MY TWENTY MINUTE UNINTERRUPTED OBSERVATION OF HIM STARTED AT 2204 HOURS ON 08/09/23. DURING THE COURSE OF THE OBSERVATION PERIOD I VISUALLY CHECKED THE INTERIOR OF HIS MOUTH FOR ANY FOREIGN OBJECTS WITH NEGATIVE FINDINGS AND HE INDICATED HE DID NOT WEAR DENTURES. DURING THE COURSE OF THE TWENTY MINUTE OBSERVATION AUGUSTINO DID NOT BELCH, REGURGITATE OR PLACE ANY FOREIGN OBJECTS INSIDE OF HIS MOUTH.

AT 2224 HOURS ON 08/09/23 I ENDED THE OBSERVATION PERIOD AND ENTERED ALL NECESSARY INFORMATION INTO THE ALCOTEST MACHINE. PRIOR TO ADMINISTERING THE ALCOTEST, ALL ELECTRONIC DEVICES WERE REMOVED FROM THE ROOM. AUGUSTINO WAS THEN REMOVED FROM THE CELL AND SEATED NEXT TO THE ALCOTEST MACHINE DESK. PRIOR TO AUGUSTINO PROVIDING HIS FIRST BREATH SAMPLE I PUT A NEW MOUTH PIECE ONTO THE HOSE AND READ HIM THE INSTRUCTIONS VERBATIM WHICH HE RELATED HE UNDERSTOOD. AUGUSTINO PROVIDED HIS FIRST BREATH SAMPLE AT 2328 HOURS. AFTER REPLACING THE MOUTH PIECE WITH A NEW ONE AND READING HIM THE INSTRUCTIONS VERBATIM AGAIN, HE PROPERLY PROVIDED HIS SECOND CONSECUTIVE BREATH SAMPLE INTO THE ALCOTEST AT 2331 HOURS. AT THE COMPLETION OF THE TEST HE WAS SEATED BACK INSIDE OF PROCESSING CELL #1. THE ALCOTEST PRINTOUT (SEQUENTIAL FILE #01335) WAS BROUGHT TO DISPATCH AND THE NUMBERS WERE RUN THROUGH THE ALCOTEST CALCULATOR. THE ALCOTEST RESULTS INDICATED AUGUSTINO HAD A B.A.C. OF 0.17% AND WERE WITHIN ACCEPTABLE TOLERANCE. PTL. NORTH WAS ADVISED AND AUGUSTINO WAS TURNED BACK OVER TO HIM FOR FURTHER PROCESSING. NOTHING FURTHER BY THIS OFFICER.

**N.J. ATTORNEY GENERAL'S STANDARD STATEMENT
FOR MOTOR VEHICLE OPERATORS (N.J.S.A. 39:4-50.2(e))
(revised & effective July 1, 2012)**

Enter Defendant's Name

Daniel F. Augustino

The police officer shall read the following:

1. You have been arrested for driving while intoxicated. N.J.S.A. 39:4-50.
2. The law requires you to submit samples of your breath for the purpose of testing to determine alcohol content.
3. A record of the taking of the breath samples, including the test results, will be made. Upon your request, a copy of that record will be made available to you.
4. After you have provided samples of your breath for testing, you have the right, at your own expense, to have a person or physician of your own selection take independent samples of your breath, blood or urine for independent testing.
5. If you refuse to provide samples of your breath, you will be issued a separate summons for the refusal. A court may find you guilty of both refusal and driving while intoxicated.
6. If a court finds you guilty of the refusal, you will be subject to various penalties, including license revocation of up to 20 years, a fine of up to \$2000, installation of an ignition interlock, and referral to an Intoxicated Driver Resource Center. These penalties may be in addition to penalties imposed by the court for any other offense of which you are found guilty.
7. You have no legal right to have an attorney, physician or anyone else present for the purpose of taking the breath samples. You have no legal right to refuse to give, or delay giving, samples of your breath.
8. Any response from you that is ambiguous or conditional, in any respect, to my request that you provide breath samples, will be treated as a refusal to submit to breath testing. Even if you agree to take the test, but then do not follow my instructions, do not properly perform the test, or do not provide sufficient breath samples, I will charge you with refusal to submit to breath testing.
9. I repeat, the law requires you to submit samples of your breath for testing. Will you submit the samples of your breath?

Answer

If the arrested person does not respond, or gives any ambiguous or conditional answer short of an unequivocal "yes," the police officer shall read the following.

Your answer is not acceptable. The law requires that you submit samples of your breath for breath testing. If you do not answer, or answer with anything other than "yes," I will charge you with refusal. Now, I ask you again, will you submit to breath testing?

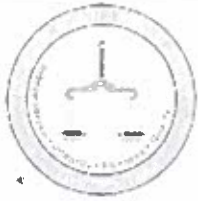

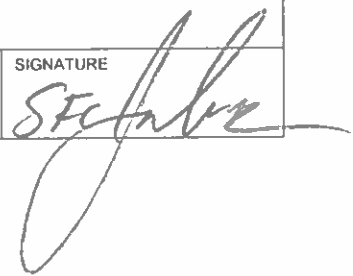

NARRATIVE On August 20th, 2023 at approximately 0320 hours: While performing a stationary radar post facing south on Route 9 nearest Main Street North, I observed a blue colored 2006 Honda Odyssey bearing NJ registration "P83LRT" approach and pass my location traveling at a high rate of speed of 56 mph within the posted 45 mph zone in violation of 39:4-98. I subsequently pulled my patrol vehicle 20-20 onto the roadway and began closing the gap between my patrol vehicle and the suspect vehicle. While traveling behind the suspect vehicle, I observed the suspect vehicle signal and begin turning left from Route 9 onto Bryant Road. At this time, I activated my overhead emergency lights of my patrol vehicle in order to initiate a motor vehicle stop with the suspect vehicle. The suspect vehicle signaled, turned right, and came to a stop within the parking lot of CVS Pharmacy located at 452 Route 9. I advised police dispatch of the location of the motor vehicle stop, the vehicle's registration and description, number of occupants, and the reason for the motor vehicle stop. I then exited my patrol vehicle in order to make contact with the operator of the motor vehicle at the passenger side front window of the vehicle. At this time, Ptl. Van De Brook of this agency also responded and made contact with the operator at the driver side front window of the vehicle. Upon making contact with the driver, I identified myself and advised the male operator that the reason I conducted the motor vehicle stop was due to him operating the motor vehicle at a rate of 56mph within the posted 45mph zone. I subsequently requested his driver's license, vehicle registration, and the vehicle insurance documentation. It should noted, my body worn camera was not activated until after I made initial contact with the male operator, once I realized my camera did not turn on when I activated my overhead emergency lights of my patrol vehicle. While speaking with the male operator, I smelled the odor of alcoholic beverage coming from within the motor vehicle and his speech appeared to be both slurred and slow....

I identified the male operator as David Decker 2nd DOB 08/18/1986 of [REDACTED] Ripple Ave, Manahawkin, NJ, 08050.

It should be noted, I previously arrested Decker 2nd on 06/10/2023 for DWI. While speaking with Decker 2nd, he related he was coming from a friend's house located in Bayville and when asked if he had consumed any alcoholic beverages throughout the evening, Decker 2nd stated "more than a few beers." During this time, Ptl. Van De Brook requested Decker 2nd exit the motor vehicle in order to perform the Standard Field Sobriety Test. It should be noted, Ptl. Van De brook did not perform the HGN test on Decker 2nd, after recalling Decker 2nd previously mentioning that he had vision issues back on 06/10/2023.

Test #1. Walk & Turn.

Results: When asked if he had any medical conditions or issues that would cause him to lose his balance while performing the test, Decker 2nd stated "no." It should be noted, while giving instructions in regards to the test, Decker 2nd left the starting position and moved onto a nearby white painted line on the ground, after relating he was bare foot and did not have any shoes to wear while performing the test. While attempting to give instructions on the starting position, Decker 2nd was instructed to place his hands by his side but instead he placed both hands behind his back before being instructed to place them by his side. Decker 2nd also did not maintain the starting position of heel to toe contact and had to be instructed to get back into the starting position after placing his feet side by side numerous times while giving instructions. It should be noted, Decker 2nd began performing the test prior to being told to do so, and had to be instructed to get back into the starting position until I instructed him to start. It appeared Decker 2nd was becoming frustrated due to having questions in regards to the test, and me having to demonstrate the test several times to Decker 2nd before he stated he understood the test instructions. While performing the test, Decker 2nd did not make heel to contact on any of the first nine steps as instructed to do, and created a gap greater than one half inch. During the turning phrase of the test, Decker 2nd did not keep his front lead foot on the ground as instructed to do but instead lifted his lead foot off the ground twice. While returning, Decker 2nd did not make heel to toe contact on any of the nine steps and created a gap greater than one half inch. Throughout the entirety of performing the test, Decker 2nd had both arms raised from his side more than six inches in order to maintain his balance, although he was instructed to keep his arms by his side while performing the test.

Test #2. One Leg Stand.

Results: While giving instructions to Decker 2nd about the test, he stated "not fair," possibly in regards to it being difficult for him to keep his arms by his side while performing the test, due to his weight. After giving instructions and demonstration, Decker 2nd stated he understood the instructions and did not have any questions. While performing the test, Decker 2nd place his raised foot on the ground several times and raised both of his arms greater than six inches away from his body in order to maintain his balance. It should be noted, Decker 2nd placed his arms behind his back at one point during the test and he to be instructed to put his arms back at his sides.

Test #3. Modified Romberg.

Results: Following instructions and demonstration, Decker stated he understood the instructions and did not have any questions. During the test, I observed that Decker 2nd had eyelid tremors and Decker's estimated passage of 30 seconds was approximately 66 seconds, indicating his perception of time was affected. When asked how he estimated the passage of 30 seconds, he stated one thousand one, one thousand two and so fourth.

Following the completion of the test, I determined Decker 2nd was operating the motor vehicle while intoxicated in violation of 39:4-50 and he was subsequently placed under arrest. Before being secured in the rear passenger seat of patrol vehicle 20-20, Decker 2nd was placed in handcuffs, double locked, searched, and advised that he would be both video and audio recorded while being transported to headquarters. Jersey Shore Towing was contacted and responded in order to take custody of the vehicle for twelve hours as per John's Law. It should be noted, while I was attempting to obtain a plastic evidence bag from the trunk of my patrol vehicle in order to secure Decker's personal property, his cell phone which was briefly placed on the top of my patrol vehicle, became wedged between the top and trunk door of my patrol vehicle, causing Decker's cell phone screen protector to crack as well as the possibility of his cell phone screen to crack as well. After securing Decker's personal property within my patrol vehicle, a search of his vehicle was conducted which yielded nothing of evidentiary value. It should be noted, I observed an empty silver colored flask located inside of a backpack that located in the front passenger side seat of the vehicle he was operating. Followoing the search, Decker 2nd was

Ptl. Sawyer of this agency was contacted and responded to headquarters for alcotest administration; see his supplemental report for additional details.

Upon completion of the alcotest administration, Ptl. Sawyer advised me that the breath samples provided by Decker 2nd were within the acceptable tolerance and that Decker 2nd's blood alcohol content yielded .09 percent blood alcohol content.

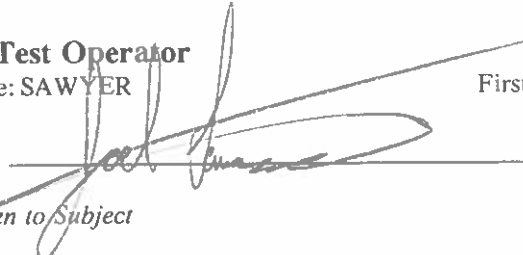

The undersigned Officer of this report responded to the Ocean Township Police Department located at 50 Railroad Avenue, Waretown, New Jersey for an Alcotest operator call out. I arrived to police headquarters and met with the arresting Officer, Patrolman North also of this agency. Ptl. North advised me that he conducted a motor vehicle stop with the accused and discovered him to be driving while intoxicated. As a result, Ptl. North made an arrest decision and transported the accused to police headquarters for processing. Ptl. North read the accused the NJ Standard Statement for Motor Vehicle Operators to which he replied "yes" to provide samples of his breath for the purpose of chemical testing.

I gathered all necessary case information and entered the processing room. Upon entering the processing room, I introduced myself and met the accused, David Decker 2nd (08/18/2023) of [REDACTED] Ripple Avenue, Manahawkin, New Jersey. I then gave David a brief summary of what I would be doing with him. It should be noted, I removed all radios and electronic devices from the processing area. I requested David to open his mouth with his tongue out and checked his oral cavity.

I initiated a twenty minute, un-interrupted mouth alcohol deprivation period with David. During these twenty minutes, David did not belch or vomit. After completion of the twenty minute mouth alcohol deprivation period, I entered all necessary data into the Alcotest unit. Upon completion of this, I removed David from the processing cell and seated him to my right.

David was able to provide two sufficient breath samples. I read David verbatim instructions to provide a breath sample before each sample was provided. After gathering these samples, I escorted David back into the processing cell. Once inside the cell, David asked if I would tell him the test results. I informed David that I would let him know as soon as the report printed from the Alcotest unit.

The test was completed and the report indicated a blood alcohol concentration of 0.09%BAC (see Alcohol Influence Report Form, Alcotest 7110 MKIII-C Ocean Township P.D. sequential file No. 01336). Upon...
