I, Detective David P. Anderson, Jr., of the Ocean County Sheriff's Department, being of full age and having been sworn to law upon our oath depose and says:

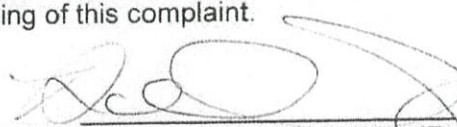
1. I am a Detective with the Ocean County Sheriff's Department, currently assigned to the Ocean County Prosecutor's Office, Computer Crime Unit.
2. In the course of my duties, I have had occasion to investigate the criminal offenses of Attempted Sexual Assault and Luring.
3. I have probable cause to believe and do believe that Chris Raynor committed the acts of Attempted Sexual Assault and Luring.
4. The basis of my probable cause is as follows:
 - a. On March 29, 2007 at approximately 12:00 p.m., this suspect, utilizing the Yahoo screenname [REDACTED] contacted members of the organization known as Perverted-Justice, who were posing as a fourteen year old female.
 - i. Perverted-Justice.com recruits volunteer contributors who pose as underage children in chatrooms. Posing from a variety of ages (standard ages are 10-15), these contributors simply go into chatrooms with fake online screen names and wait for predators to instigate conversation with them.
 - ii. Perverted-Justice has been working with the Ocean County Prosecutor's Office Computer Crime Unit in a joint 'sting' operation to target and arrest online sexual predators in and around the Ocean County area.
 - iii. Though Perverted-Justice is acting as the online undercover decoys, all cases brought to Ocean County have been reviewed and approved by the Ocean County Prosecutor's Office.
 - b. During the course of the online chat conversations, the suspect stated he wished to meet the member of Perverted-Justice for sex, specifically by saying:
 - i. The undercover, screen name [REDACTED] stated she was a '14/f/nj u?' To this, the suspect stated '22/m/nj' and

continued the conversation, stating that he wanted to meet the undercover, and lie naked with her.

c. On March 29, 2007, the suspect arrived at a predetermined meeting place. The suspect was arrested and identified as:

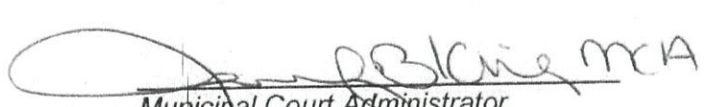
i. Chris Raynor, DOB [REDACTED] 984, SS# [REDACTED]

5. The suspect was subsequently interviewed by myself and Detective James Burgess, Brick Township Police Department. The interview was memorialized in the form of audio and video tape. The suspect was advised of his Miranda Rights and agreed to speak with the officers without an attorney present. The suspect acknowledged that he is the sole user of the screen name [REDACTED] and that he was the individual responsible for the chats with the undercover. Additionally, the suspect stated that, if he had met a fourteen (14) year old female at the meet location, he would have engaged in a sexual act with that individual.
6. This arrest was not the result of a 9-1-1 call for help. Therefore, no 9-1-1 calls for help were preserved for evidence.
7. I am signing charges of the second degree or greater. Assistant Prosecutor Madelin Einbinder has approved the signing of this complaint.

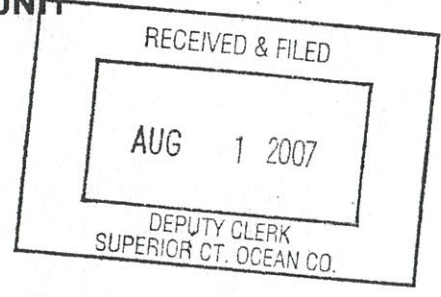

**COUNT ONE – SECOND DEGREE
ATTEMPTED SEXUAL ASSAULT**

The Grand Jurors of the State of New Jersey, in and for the County of Ocean, upon their oaths PRESENT that CHRISTOPHER J. RAYNOR, between the dates of March 27- March 29, 2007, in the Borough of Mantoloking, in the County of Ocean, and within the jurisdiction of this Court, knowingly did attempt to commit an act of sexual penetration upon an individual whom he believed to be at least 13 but less than 16 years old, and CHRISTOPHER J. RAYNOR was at least 4 years older than said individual, to wit: after chatting with an individual online over the Internet who he believed to be at least 13 but less than 16 years old, did arrive at a pre-determined location at a pre-determined time in order to commit an act of sexual penetration upon that individual, contrary to the provisions of N.J.S.A. 2C:14-2c(4) and N.J.S.A. 2C:5-1, and against the peace of this State, the Government and dignity of the same.

**COUNT TWO – SECOND DEGREE
LURING, ENTICING CHILD BY VARIOUS MEANS**

The Grand Jurors of the State of New Jersey, in and for the County of Ocean, upon their oaths PRESENT that CHRISTOPHER J. RAYNOR, between the dates of March 27-March 29, 2007, in the

Borough of Mantoloking, in the County of Ocean, and within the jurisdiction of this Court, did attempt, via electronic or any other means, to lure or entice a child or one who he reasonably believed to be a child into a motor vehicle, structure or isolated area, or to meet or appear at any other place, with a purpose to commit a criminal offense with or against the child, to wit: did arrive at a pre-determined location at a pre-determined time with the purpose to commit an act of sexual penetration upon an individual whom he believed to be a child at least 13 but less than 16 years old, contrary to the provisions of N.J.S.A. 2C:13-6, and against the peace of this State, the Government and dignity of the same.
