DURING A LAWFUL MOTOR VEHICLE STOP AND POLICE INVESTIGATION INTO POSSIBLE NARCOTICS USE AND DISTRIBUTION THE DEFENDANT WAS FOUND TO BE IN POSSESSION OF 2 WAX FOLDS OF SUSPECT HEROIN, 1 PILL IDENTIFIED TO BE XANAX, 3 SYRINGES, 1 CLEAR GLASS PIPE WITH BURNT RESIDUE, A BLACK SPOON WITH WHITE POWDER AND CASH. 2. I am aware of the facts above because: (Included, but not limited to: your observations, statements of eyewitnesses, defendant's admission, etc.)

I OBSERVED TWO FEMALE LOITERING AT THE A MOTEL IN TOWN KNOWN FOR DRUG ACTIVITY AND CRIME. I WITNESSED A SILVER SEDAN PULL INTO THE PARKING LOT OF THE MOTEL DRIVEN BY A MALE WITH A FRONT SEAT FEMALE PASSENGER. AFTER PULLING INTO PARKING LOT, NEITHER OCCUPANT EXITED THE VEHICLE. ONE OF THE FEMALES THAT WAS LOITERING AT THE MOTEL, GOT INTO THE BACKSEAT AND SPENT A VERY SHORT AMOUNT OF TIME IN THE VEHICLE. THE VEHICLE THEN EXITED THE LOT AND PROCEEDED THE NORTH ON OCEAN AVE. THE VEHICLE WAS STOPPED. AFTER SPEAKING WITH DRIVER, HE SIGNED OFF ON A CONSENT TO SEARCH THE VEHICLE IN ITS ENTIRETY.
