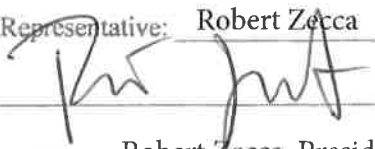

ADDENDUM #1

1. Attached are the shop drawings for the fitness court. The Township will be furnishing the equipment and surface tiles. The contractor will assemble all fitness equipment and install sports floor tiles.
2. The Township will be installing a lawn sprinkler in the amphitheater seating area. The contractor shall coordinate with the lawn sprinkler company and provide an area in the Mechanical room for the sprinkler control panel and 1" water line stub.
3. A third flag pole shall be installed. All flag poles are to be furnished by the contractor.
4. Pavilion railings are to be furnished and installed by the contractor. The railing along the open-end of the pavilion shall be in 8' removable sections in sleeves, with the ability to be locked or bolted in place.
5. All concrete, asphalt, wood chips, sand, and pavers to be furnished and installed by contractor.
6. Electrical requirements for spray pad are 120 vac/1 ph/60 hz/30 amp with neutral.
7. All picnic tables will utilize S-2 surface mount detail.
8. Footings for amphitheater are to be minimum 3' deep.
9. Ramp and stairs to Amphitheater to be poured in place concrete with 3' minimum deep footings.
10. Exposed vertical concrete surfaces on Amphitheater to be finished with cultured stone veneer same as rest of Amphitheater.

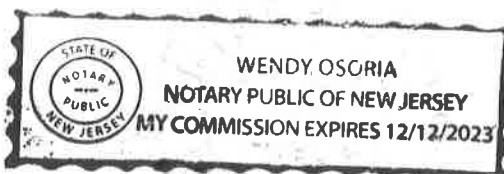

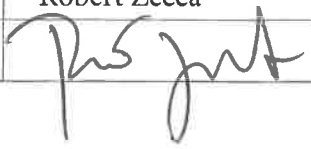
