On Thursday January 26, 2017 I was dispatched to 31 Central Pkwy. for a report of a unknown male attempting to make entry into a residence.

Upon my arrival I met with the homeowner, Angel Villanueva. Mr. Villanueva began by stating that he was not home during the incident, but he was contacted by his wife at approximately 0945 asking him if he had left the back gate open. He informed her that he did not leave it open, at this point he decided to check the cameras he has on his house. He was able to check to see when the cameras motion detectors were activated. While doing this he was able to get video of a white male between 55 and 65 years old, gray hair carrying a camera and paperwork. In the video the male walks up to the front door takes a pictures and attempts to open the door which was locked. The male then goes to the back door, this door is secured by a code lock. The male attempt several times to enter a code but is unable to unlock the door. He then returns to the front door, this time ringing the door bell but Mr. Villanueva's wife did not answer. After a short period of time the male leaves the property.

Mr. Villanueva stated that he has never seen the man before and only a few people have the code to the back door. At this time there was no other evidence to process and Mr. Villanueva will be saving the security camera footage to be picked up at a later date.
