Kean University</u> , GRC Complaint No. 2013-323 (Oct. 2014) (“[A] custodian may redact [attorney or consultant bills or invoices] to remove any information protected by attorney-client privilege”). Hereinafter referred to as “Attorney-Client Privilege.”

Borough of West Cape May</u> , GRC Complaint No. 2014-143 (July 2015); <u>Scheeler v. Township of Galloway</u> , GRC Complaint No. 2012-151 (July 2013); <u>O’Boyle v.
