OPRA specifically provides that a “government record” shall not include “any record within the attorney-client privilege.” Notably, OPRA permits records to be redacted to remove any information protected by the attorney-client privilege. <u>See Rodriguez v. Kean University</u> , GRC Complaint No. 2013-323 (Oct. 2014) (“[A] custodian may redact [attorney or consultant bills or invoices] to remove any information protected by attorney-client privilege”). Hereinafter referred to as “Attorney-Client Privilege.”

					Contains mental impressions, conclusions, opinion or theories protected by the attorney work product privilege. New Jersey law exempts from public disclosure attorney work product, consisting of “the mental impressions, conclusions, opinions or legal theories” shared by legal counsel. <u>Id.</u> (citing N.J.S.A. 47:1A-1.1 and N.J.S.A. 47:1A-9); see also <u>Scheeler v. Borough of West Cape May</u>, GRC Complaint No. 2014-143 (July 2015); <u>Scheeler v. Township of Galloway</u>, GRC Complaint No. 2012-151 (July 2013); <u>O’Boyle v. Bor. of Longport</u>, 218 N.J. 168 (2014); <u>Keddie v. Rutgers, State University</u>, 148 N.J. 36 (1997). Hereinafter referred to as “Work Product Privilege.” Contains information subject to the privacy interest protected and set forth in N.J.S.A. 47:1A-1, which provides that “a public agency has a responsibility and an obligation to safeguard from public access a citizen’s personal information with which it has been entrusted when disclosure thereof would violate the citizen’s reasonable expectation of privacy.” <u>Serrano v. South Brunswick Twp.</u>, 358 N.J. Super. 352, 368-69 (App. Div. 2003). Hereinafter the “Privacy Exemption.” Contains information exempt from disclosure pursuant to the “personnel records” exemption. See N.J.S.A. 47:1A-10; see also <u>Kovalcik v. Somerset Cnty.</u>
