The Morris County Prosecutor's Office received your Open Public Records Act (OPRA) request dated September 10, 2025, on September 10, 2025, and it was received by the records custodian on the same date. You requested the following:

Please provide copies of ANY and ALL invoices and or Purchase Orders for Taser International or AXON.

Our office made attempts to reach you on September 17, 2025 and September 22, 2025, for clarification regarding your records request. Your above request does not specify a time range. Without such clarification, your request is invalid under OPRA as it fails to identify a specific record, or records, desired. MAG Entm't, LLC v. Div. of Alcoholic Beverage Control, 375 N.J. Super. 534, 550 (App. Div. 2005); N.J.S.A. 47:1A-1 to -13. Instructive guidance has been provided by the Appellate Division when it concluded that "while an exact definition of an impermissibly overly broad request is abstract, courts have found requests that require a custodian to exercise his discretion, survey employees, or undertake research to determine whether a record is responsive are overly broad and not encompassed by OPRA." Shipyard Associates, L.P. v. City of Hoboken, A-3794-13T1, 2015 WL 10352982, at *4 (N.J. Super. Ct. App. Div. Sept. 1, 2015).

Absent clarification, this OPRA request is now deemed answered and closed.
