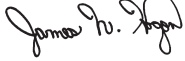

1. Use **ONLY** a pencil or black or blue ink pen to mark your ballot. **CORRECT MARK** ●
 2. Completely fill in the oval to the right of your selections. Do not vote for more candidates than are to be elected to any office.
 3. Write-in candidate box is for anyone wishing to vote for any person whose name is not printed on the ballot. Write the name of the person you wish to vote for in the appropriate (write-in) box and fill in the oval to the right.
 4. If you approve the Act/Public Question, fill in the oval to the right of the word "YES". If you disapprove the Act/Public Question, fill in the oval to the right of the word "NO".
 5. If you tear, soil, deface or incorrectly mark this ballot, return it to James N. Hogan, County Clerk and obtain another ballot.
