Supplemental Narrative

10/03/2024 00:31:12 Printz, Tyler

On the above date and time while stationary monitoring traffic near the intersection of Main Avenue and Forsyth St, this officer observed a vehicle traveling north bound on Main Avenue at a high rate of speed. This officer activated my front radar and clocked the target vehicle at 50 MPH in a posted 30 MPH zone. This officer safely turned my patrol vehicle around and began to follow behind the vehicle in question. While following behind the vehicle this officer observed the vehicle having a difficult time maintaining there lane of travel. The vehicle crossed approximately halfway over the painted median into the south bound lane near the intersection of Main Avenue and Bridge Avenue. This officer observed the vehicle cross halfway over the painted median near the intersection of Main Avenue and Mount Street and then again crossed over the painted median near the intersection of Main Avenue and Bridge Avenue. I then activated my emergency lights and conducted a motor vehicle stop near the intersection of Main Avenue and Osborne Avenue. This officer then advised OCR the location of my stop and the NJ registration D72PBL. This officer then exited my patrol vehicle and came in contact with the registered owner later identified as Tracey Scialli. This officer asked Ms. Scialli to provide me with her license, registration and proof of insurance. Ms. Scialli was able to quickly provide me with her registration and proof of insurance but was having a difficult time locating her drivers license. It should be noted that Ms. Scialli eyes were glassy and her speech was slurred and there was a strong odor of alcoholic beverage coming from inside the cabin of the vehicle. This officer asked Ms. Scialli where she was coming from tonight which she replied Seaside. I then asked Ms. Scialli where she's heading to which she stated

Princeton Avenue in Brick. I then asked Ms. Scialli if she has been drinking at all which she replied "A little bit" I then asked Ms. Scialli how much she had to drink and she replied "a little bit". Based on all my observations this officer had Ms. Scialli step out of her vehicle to perform field sobriety tests.

The first test this officer conducted was the alphabet test. This officer asked Ms. Scialli what was her highest level of education was which she replied "College and educated" I then asked her if she was familiar with the English alphabet which she replied yes I am. I then explained to Ms. Scialli that she is going to recite the alphabet A-Z without singing, humming or grouping the letters together. I then demonstrated to Ms. Scialli how the test should be performed. I then instructed Ms. Scialli to begin the test. Ms. Scialli began the test by quickly reciting the alphabet. I then stopped Ms. Scialli and re explained the instructions. Ms. Scialli was able to get through the letters A-H then recited the letter R,J,K, then grouped the letter L,M,N,O,P together and properly recited the rest of the alphabet. This officer concluded this test and moved onto the next test.

The second test this officer conducted was the one leg stand. This officer asked Ms. Scialli if she has any issues with her lower extremities which she replied no sir. I then explained to Ms. Scialli that she is going to keep her hands down to her side and lift what ever foot she chooses six inches off the ground and count one- thousand-one, one- thousand-two, one -thousand- three, and so on until I tell you to stop. I then demonstrated the test to Ms. Scialli. Ms. Scialli was instructed to begin the test. Ms. Scialli lifted her left leg and was not able to count to one- one thousand until she dropped her foot. Ms. Scialli then raised her leg again and then dropped her foot down at two-one- thousand. She then lifted her left leg again and was able to get to nine one thousand but was using her arms to help keep her balance. I asked Ms. Scialli if she would like to try the test again which she said sure. This officer then explained and demonstrated how the test should be performed. Ms. Scialli then began the test for the second time. This time Ms. Scialli lifted her leg up then quickly dropped her foot at two one thousand. Ms. Scialli then kept counting but would not lift her foot off the ground. I then explained to Ms. Scialli that I will demonstrate the test to her again since she was not lifting her foot off the ground. Ms. Scialli said "Fuck this" I then explained to Ms. Scialli that the tests are to check to see if she has the ability to drive. Ms. Scialli stated that she is going to Bridge Avenue then to Beaverdam Road then onto Princeton. This officer then advised her that she has already passed Bridge Avenue. Ms. Scialli paused for a second and said no I am going home. This officer explained and demonstrated the test again. This time Ms. Scialli was able to get to one thousand fourteen before she dropped her foot. This officer then concluded this test and moved onto the next test.

The third test this officer performed was the walk and turn test. This officer had Ms. Scialli put her left foot in front of her right foot heel-to-toe and her arms down to her side while I explained the test. It should be noted that Ms. Scialli was not able to stand in the starting position while I explained and demonstrated the test. On Ms. Scialli first attempt she lost her balance on her second and third step and was not walking heel to toe all while raising her arms. Ms. Scialli continued on and lost her balance again on her seventh, eighth and ninth step. Ms. Scialli did not follow my instructions she did not count each step out loud and took twenty five steps when the instructions were to take nine heel-to-toe steps. This officer then re explained and demonstrated the test to Ms. Scialli. This time Ms. Scialli was able to get to her fourth step before she lost her balance. Ms. Scialli then again lost her balance on her ninth step. This officer had to advise Ms. Scialli that she now needs to take nine heel-to-toe steps back. On the way back Ms. Scialli lost her balance and was not able to go heel to toe on her fifth, sixth, seventh, and eighth step. This officer then concluded this test and moved onto the final test.

The last test this officer performed was the Horizontal Gaze Nystagmus test. I asked Ms. Scialli if she had any issues with her eyes which she replied yes glasses. This officer instructed Ms. Scialli to look at the tip of the pen and follow it with her eyes only and not move her head. This officer held the pen approximately twelve inches from Ms. Scialli eyes and just above her eye level. This officer observed equal pupil size and equal tracking. I observed a lack of smooth pursuit in both eyes. This officer observed a distinct and sustained nystagmus at maximum deviation in Ms. Scialli right eye but was not able to observe her left eye since she kept moving her head. Onset of nystagmus prior to 45 degrees was present in both Ms. Scialli left and right eye. Vertical nystagmus was not detected. It should be noted while performing this test Ms. Scialli kept swaying back and

forth and an odor of alcoholic beverage was emanating off of her. This officer then concluded this test.

Based on all my observation this officer placed Ms. Scialli under arrest for driving while intoxicated. Officer Sellers had OCR contact All Time Auto Body for impound of the vehicle as per John's Law. Ms. Scialli was then handcuffed utilizing the double locking method. Officer Sellers then searched and placed Ms. Scialli in the back of patrol vehicle 207 while this officer grabbed Ms. Scialli belongings from her vehicle. This officer then transported Ms. Scialli back to police headquarters. Once back at headquarters this officer read Ms. Scialli the Miranda warning and the New Jersey Motor Vehicle Commission Stand Statement for operators of a motor vehicle. Ms. Scialli stated that she did not want to submit samples of her breath. I then read the mandatory statement that her answer was not acceptable and that the law requires her to submit samples of her breath for testing. Ms. Scialli was advised that any answer other than yes will be treated as a refusal to submit samples of her breath. Ms. Scialli then refused again. I then advised Ms. Scialli that she will now be charged with refusal to submit to breath samples. Dsgt Sherman went over intake form with Ms. Scialli. Ms. Scialli made suicidal statements specifically by saying she wants to shoot herself because her life is over now. Ms. Scialli continued on to make suicidal statements while laughing hysterically and displaying abnormal behavior. Dsgt Sherman then contacted OCR to have First Aid come to HQ to transport Ms. Scialli to Ocean Medical Center for a PESS evaluation. This officer then began the refusal process by pressing the green button on the green button on the Alcotest 3310 serial number ARMH-0328. The processing room was free of all cellular devices and radios. When the unit was ready I inputted the required information to run the tests. After all the information was inputted into the Alcotest machine this officer pressed the menu button on the Alcotest display screen. The display screen then prompted a refusal option which this officer pressed and selected. Ms. Scialli was issued six motor vehicle summons each with a mandatory court date scheduled for 11/07/24 @ 4:00 PM. Since Ms. Scialli was transported to Ocean Medical Center this officer was not successful in explaining each summons due to her current medical situation. When Ms. Scialli was released from Ocean Medical Center on 10/03/24 she arrived at police headquarters and Patrolman Vaughn explained each summons to Ms. Scialli.
