AWARDING OF CONTRACT FOR THE BAYSIDE DRIVE IMPROVEMENT PROGRAM

WHEREAS, the Borough of Atlantic Highlands desires to further advance the Bayside Drive Improvement Program that is supported by the New Jersey DOT with funding received in 2019 and 2020 under the DOT's Municipal Aid Programs; and,

WHEREAS, N.J.S.A. 40A: 11-4 requires that every contract awarded by the contracting agent, for the provision of goods or services, the cost of which in the aggregate exceeds the bid threshold shall be awarded by resolution of the governing body of the contracting unit to the lowest responsive and responsible bidder after public advertising of bids and bidding therefore; and,

WHEREAS, the Borough solicited bid proposals for its Bayside Drive Improvement Program and on March 2, 2021 six (6) bids were received from qualified contractors; the proposal soliciting separate pricing and quotations on the base proposal and one (1) alternate/additional item; and,
