WHEREAS, the City of Hackensack desires to improve the safety and structure of the public parking garage on Atlantic Street; and

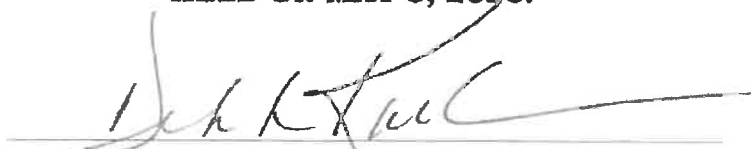
WHEREAS, the City solicited bid proposals for the renovation of said parking structure; and
