The Owner reserves the right to award a Contract for the work included in the Base Bid or to award the Base Bid plus a Supplemental Bid Item. The evaluation of the bids for the determination of the apparent low bidder will be based upon the Total Amount of the Base Bid and/or Supplemental Bid Item. The decision to award the Supplemental Item will be made by the Owner after the receipt of bids, and will be based on the bid prices, available funding and at the sole discretion of the Township of Chatham. All bidders must submit prices for the Base Bid and the Supplemental Bid Item. Any Bid which does not contain bid prices for the Base Bid Items and the Supplemental Item may be considered non-responsive. Only a single award will be made to a single contractor.
