WHEREAS, eight bids, which are outlined on the Engineer's report of May 30, 2024, were received with South State, Inc. being the lowest responsible bidder at \$105,730.50; and

WHEREAS, the Engineer has reviewed the bids and advised that the lowest bidder has met the qualifications for the project; and

WHEREAS, the Township has received a grant from NJDOT in the amount of \$132,340.00 that covers construction costs, construction inspection and material testing; and

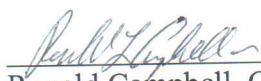
WHEREAS, the Chief Financial Officer has certified that sufficient funds are available for the award of the contract to South State, Inc. for the sum of \$105,730.50.

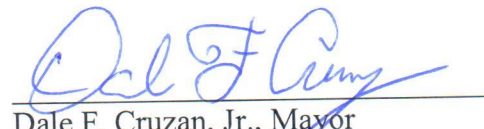
BE IT FURTHER RESOLVED that the Mayor and Clerk are authorized to execute a contract with South State, Inc. on a form approved by the Solicitor.
