Line Item: -04-00-679-411 - \$186,715.47

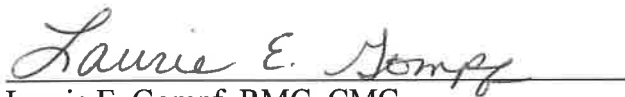
