ALL ITEMS AND WORK SHOWN ON THE CONTRACT AND DESIGN PLANS ARE TO BE PROVIDED AND COMPLETED FOR THIS PROJECT. IF THERE IS AN ITEM ON THE PLAN THAT IS NOT SPECIFICALLY SPELLED OUT IN THE SCHEDULE OF QUANTITIES AND PRICES, THE PRICE OF THAT ITEM SHALL BE INCLUDED IN THE VARIOUS OTHER BID ITEMS.

It is understood that the quantities listed below (on bid form) of the various items of work to be performed or materials to be furnished are estimates only which can be increased or decreased in the manner designated in the specifications. This bid shall be awarded as one General Contract.
