BID AWARD - PERRY STREET DRAINAGE IMPROVEMENTS**

R E S O L U T I O N

WHEREAS, bids for the Perry Street Drainage Improvements project were received, opened and read aloud on the 14th day of April 2022, by the Borough Clerk and turned over to the Borough Engineer for review and recommendation to the Mayor and Council; and,

WHEREAS, 3 bids were submitted and the Borough Engineer recommends that the bid for the Perry Street Drainage Improvements project be awarded to D&L Paving Contractors, Inc., 675 Franklin Avenue, Nutley, NJ 07110 in the amount of \$205,515.40.

WHEREAS, as required by N.J.S.A. 40A:4-57, N.J.A.C. 5:30-5.4(a)1 et seq., and any other applicable requirement, the Chief Financial Officer of the Borough of Old Tappan, County of Bergen, State of New Jersey, has ascertained that there are available sufficient uncommitted appropriations in the Capital Fund for the contract Perry Street Drainage Improvements project work within the Borough of Old Tappan;

WHEREAS, funds are provided as outlined below to award a bid to D&L Paving Contractors, Inc., 675 Franklin Avenue, Nutley, NJ 07110 in the amount of \$205,515.40.

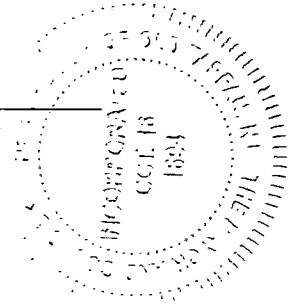
