NJSIG reads this request in conjunction with your prior OPRA requests, which sought records related to “any case captioned Paul B Dalnoky v Pinelands Regional School District.” NJSIG has searched its records for “[b]ills received from and checks made out to the law firm Lenox, Socey, Formidoni, Giordano, Lang, Carrigg & Casey LLC from December 2021 to the date of this request,” that pertain to “any case captioned Paul B Dalnoky v Pinelands Regional School District” or otherwise relate to claims or litigation to which you are a party, and we are unable to identify any documents matching this criteria. In this regard, although this information is not required as part of this OPRA response, it is noted that NJSIG does not contract with any law firm as respects “any case captioned Paul B Dalnoky v Pinelands Regional School District,” as that claim is administered by Summit Risk Services, 120 Gibraltar Road, Suite 210, Horsham, Pennsylvania, 19044.

Furthermore, although this information is not required as part of this OPRA response, NJSIG requested that Summit Risk Services provide any records of “[b]ills received from and checks made out to the law firm Lenox, Socey, Formidoni, Giordano, Lang, Carrigg & Casey LLC from December 2021 to the date of this request,” that pertain to “any case captioned Paul B Dalnoky v Pinelands Regional School District,” and they have provided the enclosed records. These records have been redacted to remove any information that is protected by the attorney-client privilege (i.e., details of specific client communications, matters of legal analysis or strategy, etc.).

These records appear to be responsive to your request. Please advise, however, if you are requesting “[b]ills received from and checks made out to the law firm Lenox, Socey, Formidoni, Giordano, Lang, Carrigg & Casey LLC from December 2021 to the date of this request” that are unrelated to “any case captioned Paul B Dalnoky v Pinelands Regional School District” and/or involve parties or claimants other than you.

These records are being provided to you electronically, pursuant to your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by NJSIG to deny access.
