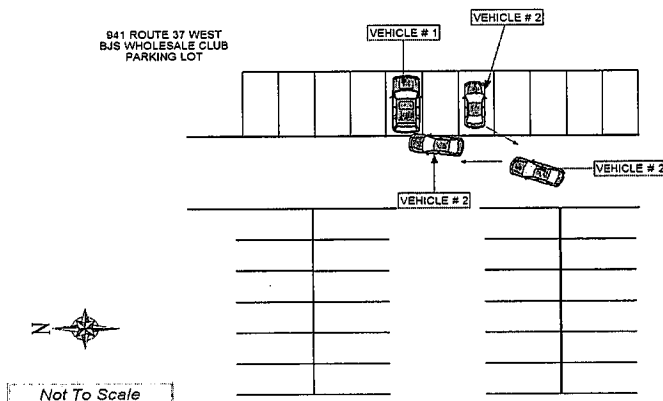

145 Crash Description/Narrative

Vehicle # 1 was parked (facing East) in a handicap parking spot at 941 Route 37 West, BJS Wholesale Club parking lot (unoccupied.) Vehicle # 2 was parked (facing East) in a handicap parking spot at 941 Route 37 West, BJS Wholesale Club parking lot. Vehicle # 2 proceeded to back up (West) out of the parking spot, and then slowly started going straight (North) in the parking lot. As Vehicle # 2 started going straight, its front passenger side bumper struck Vehicle # 1's rear passenger side bumper, causing minor damage. Driver # 2 stated he was attempting to leave the parking lot and accidentally struck the parked vehicle. All parties involved stated they do not have any injuries and refused any medical attention at this time.

An independent witness to the incident Maryann Rebenski (Phone # 732-267-0241) stated she observed the Buick (Vehicle # 2) pull out of the parking spot and then strike the parked GMC SUV (Vehicle # 1.) Ms. Rebenski stated she flagged down the driver of the Buick and advised him that he had struck a parked vehicle and contacted this police department to report the incident.

George Graulich Jr., Vehicle # 1's owner's husband, was advised of the incident and was given a report information card.
