Resolution offered by Council Member LENEUS

RESOLUTION AUTHORIZING AN EXTENSION OF AGREEMENT FOR EMERGENCY BLS SERVICES FOR THE CITY OF EAST ORANGE

WHEREAS, the City of East Orange previously entered into an emergency agreement on February 27, 2025, for a term not to exceed one hundred and twenty (120) days, with EOH Acquisition Group, LLC d/b/a Carewell Health Medical Center, located at 300 Central Avenue, East Orange, NJ 07018 ("Carewell") and its subcontractor, LIFE TECH INC. d/b/a LIFE RIDE, located at 70 South Orange Avenue, Suite 220, Livingston, NJ 07039 ("Subcontractor") (the "Agreement").

WHEREAS, the City has an obligation to provide Emergency Basic Life Support ("BLS") ambulance services to residents, commuters and visitors of East Orange, 24 hours per day, 7 days a week, 365 days per year ("24/7/365") during the term of this agreement; and

WHEREAS, N.J.S.A. 40A11-6 authorizes the use of an emergency contract for the immediate need to contract for the procurement of Emergency BLS Service; and

WHEREAS, the City, along with the Division of Procurement, has developed specifications to solicit responses, and has prepared to advertise for the Request for Proposals; and

WHEREAS, a certification attesting to said emergency is attached hereto as Exhibit "A" as is required by N.J.S.A.40A:11-6; and

WHEREAS, The City seeks to extend the emergency agreement for an additional 60-day period, from June 27, 2025, through August 27, 2025, to continue to provide said services until the RFP process is completed, and a subsequent contract is awarded; and

WHEREAS, a copy of said agreement is attached hereto as Exhibit "B".

NOW THEREFORE BE IT RESOLVED BY THE CITY OF EAST ORANGE CITY COUNCIL, that the City enter into an extension of agreement with EOH Acquisition Group, LLC d/b/a Carewell Health Medical Center, located at 300 Central Avenue, East Orange, NJ 07018 ("Carewell") and its subcontractor, LIFE TECH INC. d/b/a LIFE RIDE, located at 70 South Orange Avenue, Suite 220, Livingston, NJ 07039, to provide Emergency BLS Services to the City for an additional 60-day period.
