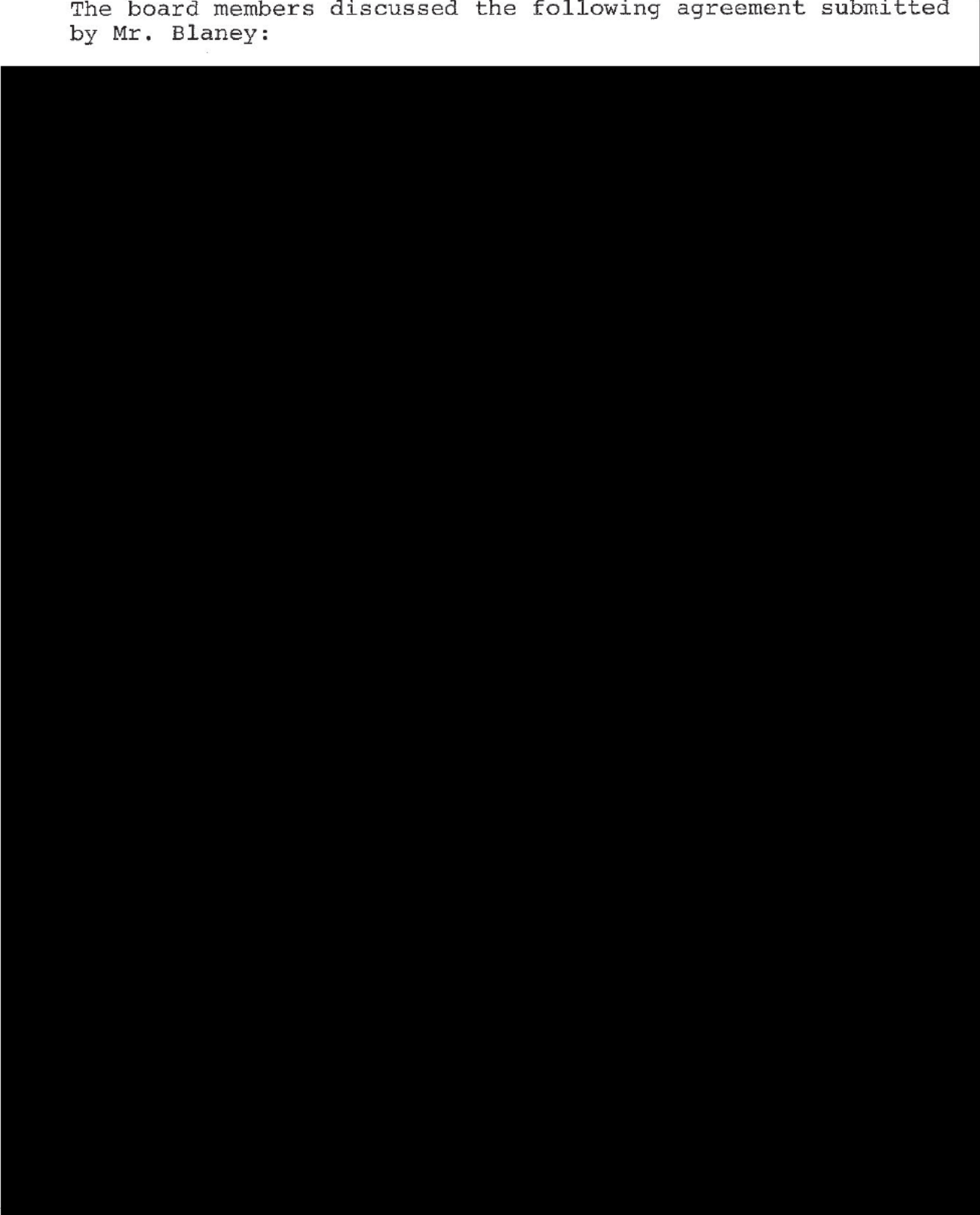

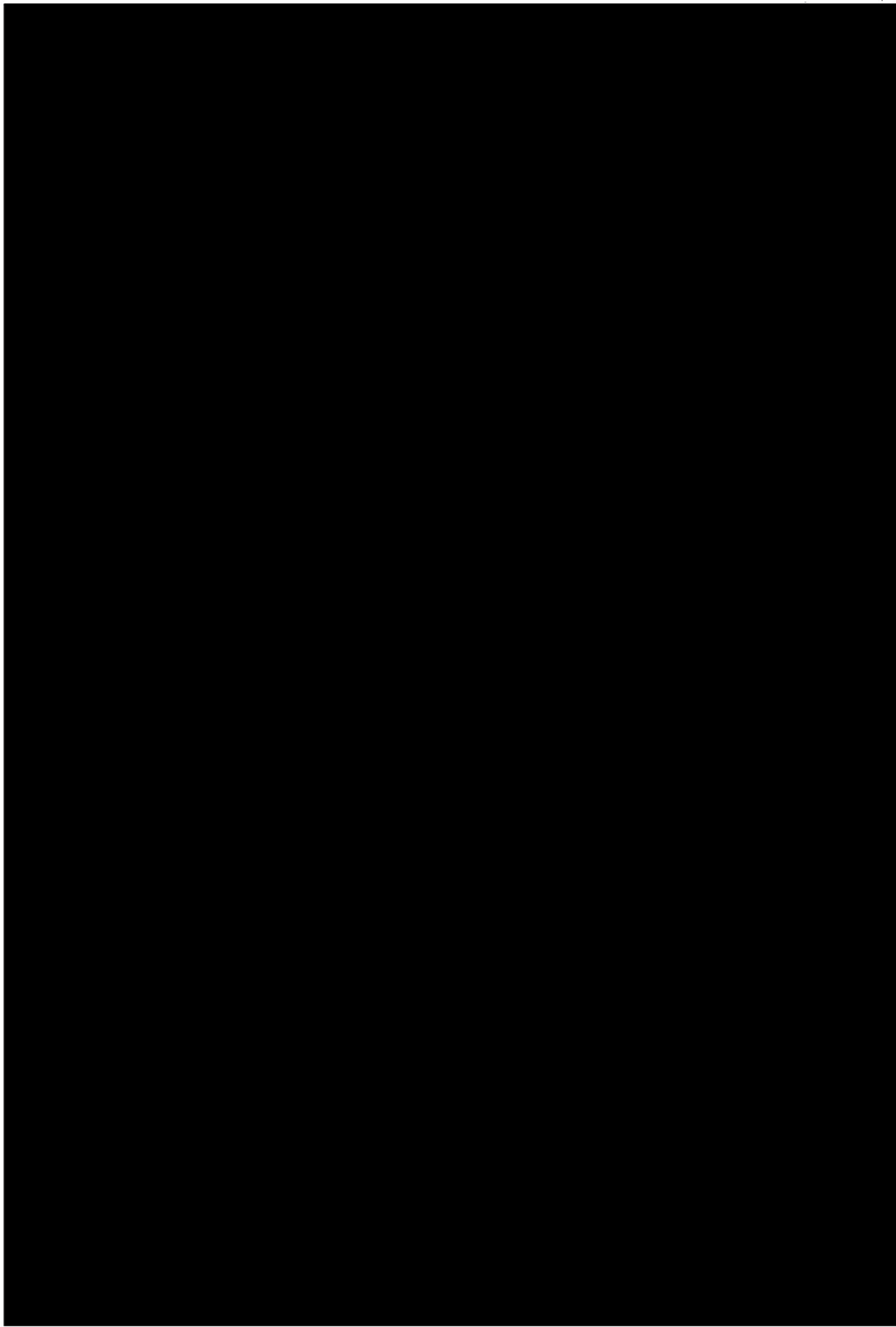

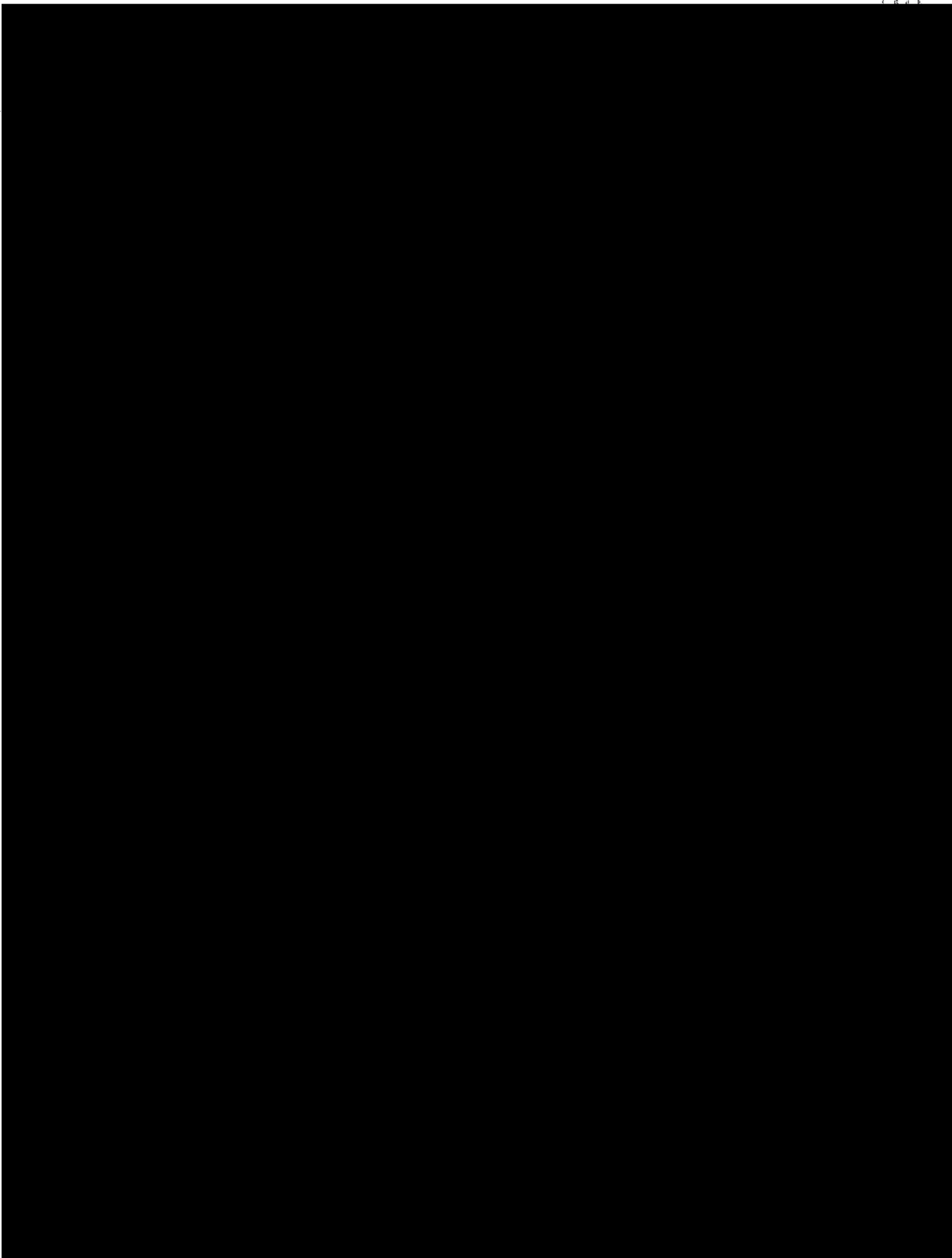
President Kull announced that the New Jersey Open Public Meeting Open Public
