PROPOSED

POLICY NO. 5131.3

POLICY FOR STUDENTS' DRIVING TO AND FROM SCHOOL

It is the policy of the Board that students refrain from driving motor vehicles to and from school unless official permission has been granted by the administration. In addition, no student shall drive or occupy any motor vehicle during school hours, without specific permission of the administration.

PROPOSED

POLICY NO. 5131.3R

REGULATIONS FOR STUDENTS' DRIVING TO AND FROM SCHOOL

1. A student must have permission from the school administration to drive a motor vehicle to school.
2. Students wishing to drive a motor vehicle must file an application for permission with the school administration. Applications for driving privileges can be obtained from the school office.
