In a continuing discussion Dr. Aragona directed that the areas of responsibility be defined between the two experts, Matthew Gillen and Mr. Ross Nagel such as supervision, monitoring while tests are being conducted, etc. Dr. Aragona further directed that the results of the tests should be set up for the Board Members and that these reports should be made to the Board and Administration, not to the media. Mr. Gillen in answer to a question posed as to how much time he expected to spend in the district noted that he did work one-half day on Wednesday, August 29th and expected to be present a full day on Friday, August 31st. He said he would set another date with Mr. Ross Nagel to prepare information for the Board of Education--his fee is \$250. a day not to exceed \$1,000.
