REGULATIONS

Motion that the Board of Education adopt the Regulations to the amendment to Policy #5141, "School Health Policy," on the first reading as follows:

REGULATIONS

Pursuant to Policy No. 5141, Subpart E, the following regulations are promulgated to implement emergency medical procedures for the safety of pupils engaged in sports and athletic events.

A. ADVANCED PLANNING. It shall be the responsibility of each school principal to maintain a complete and current schedule of all interscholastic and intramural sporting events, including any event which may be held beyond the school premises. The school principal shall also be responsible for maintaining a current schedule of all practice sessions and/or exhibition events. In the event that any sporting event or practice session or exhibition is not to be held pursuant to its scheduled time, it shall be the responsibility of the Head Coach or his designee to report the change in scheduling to the principal so that the principal may maintain the schedule required of him by this policy.
